3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Airports, Highways,

5 High-Speed Rail, Trains, and Transit: Make it in America

6 Act".

7 SEC. 2. AIRPORTS.

8 Section 50101(b) of title 49, United States Code, is

9 amended—

1	(1) by striking paragraphs (1) and (2) ;
2	(2) by redesignating paragraphs (3) and (4) as
3	paragraphs (1) and (2), respectively; and
4	(3) in paragraph (1) (as so redesignated) by
5	striking subparagraph (A) and inserting the fol-
6	lowing:
7	"(A) the cost of components and sub-
8	components produced in the United States is—
9	"(i) more than 60 percent of the cost
10	of all components of the facility or equip-
11	ment, in the case of obligations made on or
12	before December 31, 2011;
13	"(ii) more than 80 percent of the cost
14	of all components of the facility or equip-
15	ment, in the case of obligations made in
16	the period beginning January 1, 2012, and
17	ending December 31, 2012; or
18	"(iii) 100 percent of the cost of all
19	components of the facility or equipment, in
20	the case of obligations made after Decem-
21	ber 31, 2013; and".
22	SEC. 3. HIGHWAYS AND ROADWAYS.

23 Section 313(b) of title 23, United States Code, is24 amended to read as follows:

1 "(b) The Secretary may waive subsection (a) if the 2 Secretary finds that including domestic material will in-3 crease the cost of the overall project by more than 25 per-4 cent.".

5 SEC. 4. HIGH SPEED RAIL.

6 Section 24405(a)(2) of title 49, United States Code,
7 is amended to read as follows:

8 "(2) The Secretary may waive paragraph (1) if the 9 Secretary finds that including domestic material will in-10 crease the cost of the overall project by more than 25 per-11 cent.".

12 SEC. 5. AMTRAK TRAINS.

13 Section 24305(f) of title 49, United States Code, is14 amended by striking paragraph (4).

15 SEC. 6. BUSES, LIGHT RAIL, HEAVY RAIL.

16 Section 5323(j)(2) of title 49, United States Code,
17 is amended—

18 (1) by striking subparagraphs (A) and (B);

(2) by redesignating subparagraphs (C) and
(D) as subparagraphs (A) and (B), respectively; and
(3) by striking subparagraph (A)(i) (as so redesignated) and inserting the following:

23 "(i) the cost of components and sub24 components produced in the United States
