A BILL

To extend certain of the supplemental agricultural disaster assistance programs through fiscal year 2012 and to continue to fund such assistance through the Agricultural Disaster Relief Trust Fund.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Supplemental Agricul-
5 tural Disaster Assistance Act of 2012”.

1 **SEC. 2. SUPPLEMENTAL AGRICULTURAL DISASTER ASSIST-**
2 **ANCE.**

3 (a) FEDERAL CROP INSURANCE ACT.—

4 (1) LIVESTOCK INDEMNITY PAYMENTS.—Sec-
5 tion 531(c)(1) of the Federal Crop Insurance Act (7
6 U.S.C. 1531(c)(1)) is amended by striking “The
7 Secretary” and inserting “For fiscal year 2012, the
8 Secretary”.

9 (2) LIVESTOCK FORAGE DISASTER PROGRAM.—
10 Section 531(d)(2) of the Federal Crop Insurance Act
11 (7 U.S.C. 1531(d)(2)) is amended by striking “The
12 Secretary” and inserting “For fiscal year 2012, the
13 Secretary”.

14 (3) EMERGENCY ASSISTANCE FOR LIVESTOCK,
15 HONEY BEES, AND FARM-RAISED FISH.—Section
16 531(e)(1) of the Federal Crop Insurance Act (7
17 U.S.C. 1531(e)(1)) is amended by striking “The
18 Secretary shall use up to \$50,000,000 per year from
19 the Trust Fund” and inserting “For fiscal year
20 2012, the Secretary shall use up to \$50,000,000
21 from the Trust Fund”.

22 (4) PERIOD OF EFFECTIVENESS.—Section
23 531(i) of the Federal Crop Insurance Act (7 U.S.C.
24 1531(i)) is amended by striking “2011,” and insert-
25 ing “2011 (and September 30, 2012, in the case of
26 losses covered by subsections (c), (d), and (e)),”.

1 (b) TRADE ACT OF 1974.—

2 (1) LIVESTOCK INDEMNITY PAYMENTS.—Sec-
3 tion 901(c)(1) of the Trade Act of 1974 (19 U.S.C.
4 2497(c)(1)) is amended by striking “The Secretary”
5 and inserting “For fiscal year 2012, the Secretary”.

6 (2) LIVESTOCK FORAGE DISASTER PROGRAM.—
7 Section 901(d)(2) of the Trade Act of 1974 (19
8 U.S.C. 2497(d)(2)) is amended by striking “The
9 Secretary” and inserting “For fiscal year 2012, the
10 Secretary”.

11 (3) EMERGENCY ASSISTANCE FOR LIVESTOCK,
12 HONEY BEES, AND FARM-RAISED FISH.—Section
13 901(e)(1) of the Trade Act of 1974 (19 U.S.C.
14 2497(e)(1)) is amended by striking “The Secretary
15 shall use up to \$50,000,000 per year from the Trust
16 Fund” and inserting “For fiscal year 2012, the Sec-
17 retary shall use up to \$50,000,000 from the Trust
18 Fund”.

19 (4) PERIOD OF EFFECTIVENESS.—Section
20 901(i) of the Trade Act of 1974 (19 U.S.C. 2497(i))
21 is amended by striking “2011,” and inserting “2011
22 (and September 30, 2012, in the case of losses cov-
23 ered by subsections (c), (d), and (e)),”.

1 (c) AGRICULTURAL DISASTER RELIEF TRUST
2 FUND.—Section 902 of the Trade Act of 1974 (19 U.S.C.
3 2497a) is amended—

4 (1) in subsection (b)(1), by striking “2011”
5 and inserting “2012”; and

6 (2) in subsection (d), by striking “(as such sec-
7 tions are in effect on the date of the enactment of
8 the Food, Conservation, and Energy Act of 2008)”.

9 (d) WAIVER OF RISK MANAGEMENT PURCHASE RE-
10 REQUIREMENT.—Subsection (g) of section 531 of the Fed-
11 eral Crop Insurance Act (7 U.S.C. 1531) and subsection
12 (g) of section 901 of the Trade Act of 1974 (19 U.S.C.
13 2497) shall not apply in determining the eligibility of pro-
14 ducers for assistance under subsections (c), (d), and (e)
15 of such sections for losses covered by such subsections dur-
16 ing fiscal year 2012.
