A BILL

To provide for limitations on the domestic use of drones in investigating regulatory and criminal offenses, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Preserving American
5 Privacy Act of 2012”.

1 **SEC. 2. PROHIBITION ON AUTHORIZATION OF DOMESTIC**
2 **USE OF DRONES EXCEPT FOR CERTAIN LAW**
3 **ENFORCEMENT PURPOSES.**

4 No Federal agency may authorize the domestic use
5 of an unmanned aircraft (as defined in section 331 of the
6 FAA Modernization and Reform Act of 2012 (49 U.S.C.
7 40101 note)) for law enforcement purposes or for surveil-
8 lance of a United States national or real property owned
9 by that national, including by any State or local govern-
10 ment, except pursuant to warrant and in the investigation
11 of a felony. The domestic use of such an unmanned air-
12 craft shall be subject to the same limitations and excep-
13 tions as apply in the case of any other search in the rel-
14 evant jurisdiction.

15 **SEC. 3. LIMITATION ON DOMESTIC USE OF DRONES IN FED-
16 ERAL CRIMINAL INVESTIGATIONS.**

17 Chapter 205 of title 18, United States Code, is
18 amended by adding at the end the following:

19 **“§ 3119. Limitation on domestic use of drones**

20 “No Federal agency other than a Federal law en-
21 forcement agency may use in the United States or author-
22 ize any Federal officer or employee to use in the United
23 States (including by granting a permit to use) an un-
24 manned aircraft (as defined in section 331 of the FAA
25 Modernization and Reform Act of 2012 (49 U.S.C. 40101
26 note)) for law enforcement purposes or for surveillance of

1 a United States national or real property owned by that
2 national except pursuant to warrant and in the investiga-
3 tion of a felony. The domestic use of such an unmanned
4 aircraft shall be subject to the same limitations and excep-
5 tions as apply in the case of any other search. No informa-
6 tion obtained in violation of this section using such an un-
7 manned aircraft may be used in a criminal proceeding be-
8 fore a Federal court.”.

9 **SEC. 4. NO USE OF DRONE EVIDENCE IN ADMINISTRATIVE**

10 **HEARINGS.**

11 Section 556 of title 5, United States Code, is amend-
12 ed by adding at the end the following:

13 “(f) No evidence obtained by an agency using an un-
14 manned aircraft (as defined in section 331 of the FAA
15 Modernization and Reform Act of 2012 (49 U.S.C. 40101
16 note)) may be introduced in a hearing under this section.”.

17 **SEC. 5. NO AUTHORIZATION FOR DOMESTIC USE IN PRI-**

18 **VATE SURVEILLANCE.**

19 No Federal agency may authorize the domestic use,
20 including granting a permit to use, of an unmanned air-
21 craft (as defined in section 331 of the FAA Modernization
22 and Reform Act of 2012 (49 U.S.C. 40101 note)), to per-
23 mit any private person to conduct surveillance on any
24 other private person without the consent of that other pri-

1 vate person or the owner of any real property on which
2 that other private person is present.

3 **SEC. 6. RULE OF CONSTRUCTION.**

4 Nothing in this Act shall be construed to change the
5 laws regarding the permissible uses of drones for border
6 security applications within 25 miles of the United States
7 border.
