## A BILL

To authorize the placement at the former Navy Dive School at the Washington Navy Yard of a memorial to honor the members of the Armed Forces who have served as divers and whose service in defense of the United States has been carried out beneath the waters of the world.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

**3 SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Man in the Sea Memo-  
5 rial Act”.

1   **SEC. 2. ESTABLISHMENT OF MILITARY DIVERS MEMORIAL**

2                   **AT WASHINGTON NAVY YARD.**

3         (a) **MEMORIAL AUTHORIZED.**—The Secretary of the  
4   Navy may permit a third party to establish and maintain,  
5   at a suitable location at the former Navy Dive School at  
6   the Washington Navy Yard in the District of Columbia,  
7   a memorial to honor the members of the United States  
8   Armed Forces who have served as divers and whose service  
9   in defense of the United States has been carried out be-  
10   neath the waters of the world.

11         (b) **LOCATION AND DESIGN OF MONUMENT.**—The  
12   actual location at the Washington Navy Yard for the me-  
13   morial authorized by subsection (a) and the final design  
14   of the memorial shall be subject to the approval of the  
15   Secretary. In selecting the site to serve as the location for  
16   the memorial, the Secretary shall seek to maximize visitor  
17   access to the memorial.

18         (c) **MILITARY SUPPORT.**—The Secretary shall pro-  
19   vide military ceremonial support at the dedication of the  
20   memorial authorized by subsection (a).

21         (d) **USE OF FEDERAL FUNDS PROHIBITED.**—Fed-  
22   eral funds may not be used to design, procure, prepare,  
23   install, or maintain the memorial authorized by subsection  
24   (a), but the Secretary may accept and expend contribu-

1 tions of non-Federal funds and resources for such pur-  
2 poses.
