A BILL

To amend title XX of the Social Security Act to repeal the program of block grants to States for social services, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REPEAL OF THE PROGRAM OF BLOCK GRANTS**

4 **TO STATES FOR SOCIAL SERVICES.**

5 (a) REPEALS.—Sections 2001 through 2007 of the
6 Social Security Act (42 U.S.C. 1397–1397f) are repealed.

7 (b) CONFORMING AMENDMENTS.—

8 (1) Section 404(d) of the Social Security Act
9 (42 U.S.C. 604(d)) is amended—

(A) in paragraph (1), by striking “any or all of the following provisions of law:” and all that follows through “The” and inserting “the”;

(B) in paragraph (3)—

(i) by striking “RULES” and all that follows through “any amount” and inserting “RULES.—Any amount”;

(ii) by striking “a provision of law specified in paragraph (1)” and inserting “the Child Care and Development Block Grant Act of 1990”; and

(iii) by striking subparagraph (B);
and

(C) by striking paragraph (2) and redesignating paragraph (3) as paragraph (2).

(2) Section 422(b) of the Social Security Act (42 U.S.C. 622(b)) is amended—

(A) in paragraph (1)(A)—

(i) by striking “administers or supervises” and inserting “administered or supervised”; and

(ii) by striking “subtitle 1 of title XX” and inserting “subtitle A of title XX

1 (as in effect before the repeal of such sub-
2 title)”; and

3 (B) in paragraph (2), by striking “under
4 subtitle 1 of title XX,”.

5 (3) Section 471(a) of the Social Security Act
6 (42 U.S.C. 671(a)) is amended—

7 (A) in paragraph (4), by striking “, under
8 subtitle 1 of title XX of this Act,”; and

9 (B) in paragraph (8), by striking “XIX, or
10 XX” and inserting “or XIX”.

11 (4) Section 472(h)(1) of the Social Security Act
12 (42 U.S.C. 672(h)(1)) is amended by striking the
13 2nd sentence.

14 (5) Section 473(b) of the Social Security Act
15 (42 U.S.C. 673(b)) is amended—

16 (A) in paragraph (1), by striking “(3)”
17 and inserting “(2)”;

18 (B) in paragraph (4), by striking “para-
19 graphs (1) and (2)” and inserting “paragraph
20 (1)”;

21 (C) by striking paragraph (2) and redesign-
22 ating paragraphs (3) and (4) as paragraphs
23 (2) and (3), respectively.

24 (6) Section 504(b)(6) of the Social Security Act
25 (42 U.S.C. 704(b)(6)) is amended in each of sub-

1 paragraphs (A) and (B) by striking “XIX, or XX”
2 and inserting “or XIX”.

3 (7) Section 1101(a)(1) of the Social Security
4 Act (42 U.S.C. 1301(a)(1)) is amended by striking
5 the penultimate sentence.

6 (8) Section 1128(h) of the Social Security Act
7 (42 U.S.C. 1320a–7(h)) is amended—

8 (A) by adding “or” at the end of para-
9 graph (2); and

10 (B) by striking paragraph (3) and redesign-
11 ating paragraph (4) as paragraph (3).

12 (9) Section 1128A(i)(1) of the Social Security
13 Act (42 U.S.C. 1320a–7a(i)(1)) is amended by strik-
14 ing “or subtitle 1 of title XX”.

15 (10) Section 1132(a)(1) of the Social Security
16 Act (42 U.S.C. 1320b–2(a)(1)) is amended by strik-
17 ing “XIX, or XX” and inserting “or XIX”.

18 (11) Section 1902(e)(13)(F)(iii) of the Social
19 Security Act (42 U.S.C. 1396a(e)(13)(F)(iii)) is
20 amended—

21 (A) by striking “EXCLUSIONS” and insert-
22 ing “EXCLUSION”; and

23 (B) by striking “an agency that determines
24 eligibility for a program established under the

1 Social Services Block Grant established under
2 title XX or”.

3 (12) The headings for title XX and subtitle A
4 of title XX of the Social Security Act are each
5 amended by striking “**BLOCK GRANTS TO**
6 **STATES FOR SOCIAL SERVICES**” and in-
7 serting “**HEALTH PROFESSIONS DEM-**
8 **ONSTRATIONS AND ENVIRONMENTAL**
9 **HEALTH CONDITION DETECTION**”.

10 (13) Section 16(k)(5)(B)(i) of the Food and
11 Nutrition Act of 2008 (7 U.S.C. 2025(k)(5)(B)(i))
12 is amended by striking “, or title XX,”.

13 (14) Section 402(b)(3) of the Personal Respon-
14 sibility and Work Opportunity Reconciliation Act of
15 1996 (8 U.S.C. 1612(b)(3)) is amended by striking
16 subparagraph (B) and redesignating subparagraph
17 (C) as subparagraph (B).

18 (15) Section 245A(h)(4)(I) of the Immigration
19 Reform and Control Act of 1986 (8 U.S.C.
20 1255a(h)(4)(I)) is amended by striking “, XVI, and
21 XX” and inserting “and XVI”.

22 (16) Section 17 of the Richard B. Russell Na-
23 tional School Lunch Act (42 U.S.C. 1766) is amend-
24 ed—

25 (A) in subsection (a)(2)—

1 (i) in subparagraph (B)—

2 (I) by striking “—” and all that
3 follows through “(i)”;

4 (II) by striking “or” at the end
5 of clause (i); and

6 (III) by striking clause (ii); and

7 (ii) in subparagraph (D)(ii), by strik-
8 ing “or title XX”; and

9 (B) in subsection (o)(2)(B)—

10 (i) by striking “or title XX” each
11 place it appears; and

12 (ii) by striking “or XX”.

13 (17) Section 201(b) of the Indian Child Welfare
14 Act of 1978 (25 U.S.C. 1931(b)) is amended by
15 striking “titles IV–B and XX” and inserting “part
16 B of title IV”.

17 (18) Section 3803(c)(2)(C) of title 31, United
18 States Code, is amended by striking clause (vi) and
19 redesignating clauses (vii) through (xvi) as clauses
20 (vi) through (xv), respectively.

21 (19) Section 14502(d)(3) of title 40, United
22 States Code, is amended—

23 (A) by striking “and title XX”; and

24 (B) by striking “, 1397 et seq.”.

1 (20) Section 2006(a)(15) of the Public Health
2 Service Act (42 U.S.C. 300z-5(a)(15)) is amended
3 by striking “and title XX of the Social Security
4 Act”.

5 (21) Section 203(b)(3) of the Older Americans
6 Act of 1965 (42 U.S.C. 3013(b)(3)) is amended by
7 striking “XIX, and XX” and inserting “and XIX”.

8 (22) Section 213 of the Older Americans Act of
9 1965 (42 U.S.C. 3020d) is amended by striking “or
10 title XX”.

11 (23) Section 306(d) of the Older Americans Act
12 of 1965 (42 U.S.C. 3026(d)) is amended in each of
13 paragraphs (1) and (2) by striking “titles XIX and
14 XX” and inserting “title XIX”.

15 (24) Section 2605 of the Low-Income Home
16 Energy Assistance Act of 1981 (42 U.S.C. 8624) is
17 amended in each of subsections (b)(4) and (j) by
18 striking “under title XX of the Social Security
19 Act,”.

20 (25) Section 602 of the Child Development As-
21 sociate Scholarship Assistance Act of 1985 (42
22 U.S.C. 10901) is repealed.

23 (26) Section 3(d)(1) of the Assisted Suicide
24 Funding Restriction Act of 1997 (42 U.S.C.
25 14402(d)(1)) is amended by striking subparagraph

1 (C) and redesignating subparagraphs (D) through
2 (K) as subparagraphs (C) through (J), respectively.

3 (c) EFFECTIVE DATE.—The repeals and amend-
4 ments made by this section shall take effect 60 days after
5 the date of the enactment of this Act.
