## A BILL

To amend title 10, United States Code, to extend military commissary and exchange store privileges, without time-period limitation, to members of the Armed Forces who are involuntarily separated with a service-connected disability and also to extend such privileges to their dependents.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. COMMISSARY AND EXCHANGE STORE PRIVI-**  
2 **LEGES FOR INVOLUNTARILY SEPARATED**  
3 **MEMBERS WITH A SERVICE-CONNECTED DIS-**  
4 **ABILITY AND FOR THEIR DEPENDENTS.**

5 (a) EXTENSION OF PRIVILEGES.—Section 1146 of  
6 title 10, United States Code, is amended by adding at the  
7 end the following new subsection:

8 “(d) MEMBERS INVOLUNTARILY SEPARATED WITH  
9 SERVICE-CONNECTED DISABILITY; DEPENDENTS.—(1) A  
10 member of the armed forces who is involuntarily separated  
11 from active duty or the Selected Reserve and who has a  
12 service-connected disability shall be permitted to use com-  
13 missary and exchange stores on the same basis as a mem-  
14 ber of the armed forces entitled to retired or retainer pay.

15 “(2) A dependent of a member described in para-  
16 graph (1) shall be permitted to use commissary and ex-  
17 change stores on the same basis as a dependent of a mem-  
18 ber of the armed forces entitled to retired or retainer  
19 pay.”.

20 (b) IMPLEMENTATION.—The Secretary of Defense  
21 shall ensure that subsection (d) of section 1146 of title  
22 10, United States Code, as added by subsection (a), is  
23 fully operational before the end of the 90-day period begin-  
24 ning on the date of the enactment of this Act.
