Amending the Rules of the House of Representatives to establish a Committee on the Reduction of Nonessential Federal Expenditures.

Mr. Bass of New Hampshire submitted the following resolution; which was referred to the Committee on Rules

RESOLUTION

Amending the Rules of the House of Representatives to establish a Committee on the Reduction of Nonessential Federal Expenditures.

- 1 Resolved, That (a) rule X of the Rules of the House
- 2 of Representatives is amended by adding at the end the
- 3 following new clause:
- 4 "Select Committee on the Reduction of Nonessential
- 5 Federal Expenditures
- 6 "12.(a) There is established a Select Committee on
- 7 the Reduction of Nonessential Federal Expenditures
- 8 (hereafter in this clause referred to as the 'select com-
- 9 mittee'). The select committee shall be composed of two
- 10 members from each standing committee of which one shall

- 1 be from the majority party and selected by the speaker
- 2 and one shall be from the minority party and selected by
- 3 the minority leader. The speaker shall designate one of
- 4 its members as the chair and the minority leader shall des-
- 5 ignate one of its members as the vice chair.
- 6 "(b) There shall be referred to the select committee
- 7 proposed legislation relating to the elimination or reduc-
- 8 tion of all nonessential expenditures of the Government.
- 9 "(c) The select committee shall make a full and com-
- 10 plete study and investigation of all expenditures of the
- 11 Government on a continuing basis to ascertain all expendi-
- 12 tures of the Government deemed by the committee to be
- 13 nonessential.
- "(d)(1) It shall be in order, not later than 30 legisla-
- 15 tive days after the date on which a bill is reported by the
- 16 select committee for the majority leader or the majority
- 17 leader's designee to move to proceed to the consideration
- 18 of the bill. It shall also be in order for any Member to
- 19 move to proceed to the consideration of the bill at any
- 20 time after the conclusion of such 30-day period. All points
- 21 of order against the motion are waived. Such a motion
- 22 shall not be in order after the House has disposed of a
- 23 motion to proceed on the bill. The previous question shall
- 24 be considered as ordered on the motion to its adoption
- 25 without intervening motion. The motion shall not be de-

- 1 batable. A motion to reconsider the vote by which the mo-
- 2 tion is disposed of shall not be in order.
- 3 "(2) Any bill reported by the select committee shall
- 4 be considered under rules established by the Committee
- 5 on Rules, except that all points of order established in the
- 6 Congressional Budget Act of 1974, and related points of
- 7 order, against the bill and against its consideration are
- 8 waived.
- 9 "(3) Appeals from decisions of the chair relating to
- 10 the application of the Rules of the House of Representa-
- 11 tives to the procedure relating to a bill reported by the
- 12 select committee shall be decided without debate.
- 13 "(4) Except to the extent specifically provided in this
- 14 clause, consideration of a bill reported by the select com-
- 15 mittee shall be governed by the Rules of the House of Rep-
- 16 resentatives. It shall not be in order in the House of Rep-
- 17 resentatives to consider any bill within the jurisdiction of
- 18 the select committee introduced pursuant to the provisions
- 19 of this clause under a suspension of the rules pursuant
- 20 to clause 1 of rule XV or under a special rule reported
- 21 by the Committee on Rules.
- 22 "(5) Immediately following the conclusion of consid-
- 23 eration of any bill reported by the select committee, the
- 24 vote on passage of the bill shall occur without any inter-
- 25 vening action or motion. If any such bill is passed, the

- 1 Clerk of the House of Representatives shall cause the bill
- 2 to be transmitted to the Senate before the close of the
- 3 next day of session of the House. The vote on passage
- 4 shall occur not later than the last scheduled legislative day
- 5 of a session.
- 6 "(e) There shall be paid out of the applicable ac-
- 7 counts of the House such sums as may be necessary for
- 8 the expenses of the select committee. Such payments shall
- 9 be made on vouchers signed by the chairman of the select
- 10 committee and approved in the manner directed by the
- 11 Committee on House Administration. Amounts made
- 12 available under this paragraph shall be expended in ac-
- 13 cordance with regulations prescribed by the Committee on
- 14 House Administration.
- "(f) In carrying out its functions under this clause,
- 16 the select committee may—
- 17 "(1) appoint, either on a permanent basis or as
- experts or consultants, any staff that the select com-
- mittee considers necessary;
- 20 "(2) prescribe the duties and responsibilities of
- 21 the staff;
- "(3) fix the compensation of the staff at per
- annum gross rates that do not exceed the highest
- rate of basic pay, as in effect from time to time, of

2	title 5, United States Code;

- "(4) terminate the employment of any such staff as the select committee considers appropriate; and
- 6 "(5) reimburse members of the select committee 7 and its staff for travel, subsistence, and other nec-8 essary expenses incurred by them in the performance 9 of their functions for the select committee, other 10 than expenses in connection with any meeting of the 11 select committee held in the District of Columbia.
- 12 "(g) The select committee shall cease to exist upon 13 the close of the One Hundred Sixteenth Congress.".
- 14 (b) The amendment made by this resolution shall 15 take effect immediately before noon, January 3, 2013.
