A BILL

To rescind certain Federal funds identified by States as unwanted and use the funds to reduce the Federal debt.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Returned Exclusively
- 5 For Unpaid National Debt Act" or the "REFUND Act".
- 6 SEC. 2. USE OF UNWANTED FEDERAL FUNDS TO REDUCE
- 7 FEDERAL DEBT.
- 8 (a) Rescission of Unwanted Federal Funds.—
- 9 There is rescinded, from any Federal funds required to
- 10 be allocated by formula among all States that agree to

- 1 use such funds for a specified purpose, an amount equal
- 2 to the amount of such funds that would have otherwise
- 3 been allocated to a State that identifies such funds under
- 4 subsection (b) as unwanted.
- 5 (b) Identification of Funds.—Subsection (a)
- 6 shall only apply if, not later than the last date on which
- 7 an application or State plan must be submitted in order
- 8 for a State to be allocated, in an annual or biennial budget
- 9 cycle, funds described in such subsection—
- 10 (1) the State legislature with jurisdiction over
- such budget cycle adopts a concurrent resolution
- identifying the funds as unwanted; and
- 13 (2) the State submits notice of the resolution
- described in paragraph (1) to the agency head re-
- sponsible for allocation of the funds, in such form
- and manner and containing such information as the
- agency head determines appropriate to make the de-
- termination in subsection (c).

- 20 SCINDED.—An agency head that receives notice described
- 21 in subsection (b)(2) shall determine and report to the Of-
