A BILL

To authorize the Secretary of the Interior to accept from the Board of Directors of the National September 11 Memorial and Museum at the World Trade Center Foundation, Inc., the donation of title to The National September 11 Memorial and Museum at the World Trade Center, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National September
- 5 11 Memorial and Museum Act of 2011".

SEC. 2. FINDINGS; PURPOSE.

2 (a) FINDINGS.—Congress finds that—	-
--------------------------------------	---

- (1) on September 11, 2001, the United States was attacked and our world was changed forever when terrorists murdered nearly 3,000 innocent people at the World Trade Center, at the Pentagon, and in a field in Shanksville, Pennsylvania, in the largest terrorist attack ever committed in the United States;
- (2) millions of people from every State and every country have visited Ground Zero to pay their respects;
- (3) established in 2003, the National September 11 Memorial and Museum at the World Trade Center Foundation, Inc., a nonprofit organization described in section 501(c)(3) of the Internal Revenue Code of 1986, has been dedicated to raising funds for and overseeing the design, construction, and operation of the Memorial and Museum at the World Trade Center site;
- (4) the Memorial will ensure that future generations never forget the thousands of people who were killed by the terrorist attack on September 11th, 2001, in New York, Pennsylvania, and Virginia as well as those who died in the terrorist bombing at the World Trade Center on February 26, 1993:

1	(5) the Memorial—
2	(A) will further recognize the thousands
3	who survived the terrorist attacks and all who
4	demonstrated extraordinary compassion in the
5	aftermath;
6	(B) will ensure, through educational pro-
7	grams, that the history of September 11, 2011,
8	and the implications of that day, continue to be
9	told, especially to the youth of the United
10	States; and
11	(C) will be a resource to the more than
12	600 September 11 Memorials being established
13	throughout the United States;
14	(6) the Memorial is scheduled to open on the
15	10th anniversary of the terrorist attacks, while the
16	Museum is scheduled to open in 2012;
17	(7) it is projected that the Memorial will be one
18	of the most visited venues in the United States, with
19	millions of visitors each year, reflecting the enor-
20	mous impact the terrorist attacks had on the United
21	States and the world;
22	(8) throughout the history of the United States,
23	Congress has stepped forward to authorize operating

funds, in public and private partnership with private

1	donors, for memorials and museums of national sig-
2	nificance;
3	(9) the Memorial is a true public and private
4	partnership, recognized as a public charity under the
5	Internal Revenue Code of 1986; and
6	(10) of the funds raised for the Memorial and
7	Museum—
8	(A) nearly 60 percent have come from over
9	300,000 private donations; and
10	(B) 40 percent have come from public
11	sources.
12	(b) Purpose.—The purpose of this Act is to promote
13	the purposes of the Memorial, including—
14	(1) remembering and honoring the thousands of
15	innocent men, women, and children murdered by ter-
16	rorists in the horrific attacks of February 26, 1993,
17	and September 11, 2001;
18	(2) respecting the site made sacred through
19	tragic loss;
20	(3) recognizing—
21	(A) the endurance of the individuals who
22	survived the terrorist attacks;
23	(B) the courage of the individuals who
24	risked their lives to save others: and

1	(C) the compassion of the individuals who
2	supported the people of the United States in
3	our darkest hours;
4	(4) ensuring, through educational programs,
5	that the history of September 11, 2001, and the im-
6	plications of that day continue to be told, especially
7	to the youth of the United States; and
8	(5) ensuring that the Memorial will be a re-
9	source to the more than 600 September 11 Memo-
10	rials being established throughout the United States.
