A BILL

To require a five-year strategic plan for the Office of Rural Health of the Veterans Health Administration of the Department of Veterans Affairs for improving access to, and the quality of, health care services for veterans in rural areas.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Rural Veterans Health
- 5 Care Improvement Act".

1	SEC. 2. FIVE-YEAR STRATEGIC PLAN FOR OFFICE OF
2	RURAL HEALTH OF THE DEPARTMENT OF
3	VETERANS AFFAIRS.
4	(a) Strategic Plan Required.—
5	(1) In General.—Not later than 180 days
6	after the date of the enactment of this Act, the Di-
7	rector of the Office of Rural Health of the Veterans
8	Health Administration of the Department of Vet-
9	erans Affairs shall develop a strategic plan for the
10	Office of Rural Health for improving access to, and
11	the quality of, health care services for veterans in
12	rural areas that covers the five-year period com-
13	mencing on the date of the issuance of the plan by
14	the Director.
15	(2) Consultation.—The Director of the Of-
16	fice of Rural Health shall develop the plan in con-
17	sultation with the following:
18	(A) The Director of the Health Care Re-
19	tention and Recruitment Office of the Depart-
20	ment.
21	(B) The Director of the Office of Quality
22	and Performance of the Department.
23	(C) The Director of the Office of Care Co-
24	ordination Services of the Department.

- 1 (b) Elements.—The plan required by subsection (a)
 2 shall include, for the period covered by the plan, the fol3 lowing:
- 4 (1) Goals and objectives for the recruitment 5 and retention by the Veterans Health Administra-6 tion of health care personnel in rural areas.
 - (2) Goals and objectives for ensuring timeliness and improving quality in the delivery of health care services by the Veterans Health Administration in rural areas through contract and fee-basis providers.
 - (3) Goals and objectives for the implementation, expansion, and enhanced use of telemedicine services by the Veterans Health Administration in rural areas, including through coordination with other appropriate offices of the Department.
 - (4) Goals and objectives for ensuring the full and effective use of mobile outpatient clinics by the Veterans Health Administration for the provision of health care services in rural areas, including goals and objectives for the use of such clinics on a fully mobile basis and for encouraging health care providers who provide services through such clinics to do so in rural areas.

2	erans Health Administration facility that serves a
