## A BILL

To amend title 10, United States Code, to authorize space-available travel on military aircraft for members of the reserve components, a member or former member of a reserve component who is eligible for retired pay but for age, widows and widowers of retired members, and dependents.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “Space-Available Act  
3 of 2012”.

4 **SEC. 2. ELIGIBILITY OF ACTIVE AND RESERVE MEMBERS,**  
5 **RETIREES, GRAY AREA RETIREES, AND DE-**  
6 **PENDENTS FOR SPACE-AVAILABLE TRAVEL**  
7 **ON MILITARY AIRCRAFT.**

8       (a) IN GENERAL.—Chapter 157 of title 10, United  
9 States Code, is amended by inserting after section 2641b  
10 the following new section:

11 **“§ 2641c. Space-available travel on department of de-**  
12 **fense aircraft: eligibility**

13       “(a) AUTHORITY TO ESTABLISH BENEFIT PRO-  
14 GRAM.—The Secretary of Defense may establish a pro-  
15 gram to provide transportation on Department of Defense  
16 aircraft on a space-available basis. The program shall be  
17 conducted in a budget neutral manner.

18       “(b) BENEFIT.—If the Secretary establishes such a  
19 program, the Secretary shall, subject to section (c), pro-  
20 vide the benefit equally to the following individuals:

21               “(1) Active duty members and members of the  
22 Selected Reserve holding a valid Uniformed Services  
23 Identification and Privilege Card.

24               “(2) A retired member of an active or reserve  
25 component, including retired members of reserve  
26 components, who, but for being under the eligibility

1 age applicable to the member under section 12731  
2 of this title, would be eligible for retired pay under  
3 chapter 1223 of this title.

4 “(3) An unremarried widow or widower of an  
5 active or reserve component member of the armed  
6 forces.

7 “(4) A dependent that—

8 “(A)(i) is the child of an active or reserve  
9 component member or former member described  
10 in paragraph (1) or (2); or

11 “(ii) is the child of a deceased member en-  
12 titled to retired pay holding a valid Uniformed  
13 Services Identification and Privilege Card and a  
14 surviving unremarried spouse; and

15 “(B) is accompanying the member or, in  
16 the case of a deceased member, is the surviving  
17 unremarried spouse of the deceased member or  
18 is a dependent accompanying the surviving  
19 unremarried spouse of the deceased member.

20 “(5) The surviving dependent of a deceased  
21 member or former member described in paragraph  
22 (2) holding a valid Uniformed Services Identification  
23 and Privilege Card, if the dependent is accom-  
24 panying the member or, in the case of a deceased  
25 member, is the surviving unremarried spouse of the

1       deceased member or is a dependent accompanying  
2       the surviving unremarried spouse of the deceased  
3       member.

4           “(6) Other such individuals as determined by  
5       the Secretary in the Secretary’s discretion.

6       “(c)   DISCRETION   TO   ESTABLISH   PRIORITY  
7   ORDER.—The Secretary, in establishing a program under  
8   this section, may establish an order of priority that is  
9   based on considerations of military needs and military  
10   readiness.”.

11       (b) CLERICAL AMENDMENT.—The table of sections  
12   at the beginning of such chapter is amended by inserting  
13   after the item relating to section 2641b the following new  
14   item:

      “2641c. Space-available travel on Department of Defense aircraft: eligibility.”.
