Mr. NELSON of Florida introduced the following bill; which was read twice and  
referred to the Committee on Veterans' Affairs

## A BILL

To direct the Secretary of Interior to establish a veterans  
conservation corps, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Veterans Conservation  
5       Corps Authorization Act”.

6       **SEC. 2. DEFINITIONS.**

7       In this Act:

8               (1) CORPS.—The term “corps” means the vet-  
9       erans conservation corps established under section  
10      3(a).

1           (2) ELIGIBLE VETERAN.—The term “eligible  
2       veteran” means a veteran (as the term is defined in  
3       section 101 of title 38, United States Code) that, as  
4       of the date on which the application for the corps is  
5       submitted—

6                   (A) is unemployed;

7                   (B) is not enrolled in any other Federal  
8       training program; and

9                   (C) meets any other criteria that the Sec-  
10      retary determines to be appropriate.

11           (3) SECRETARY.—The term “Secretary” means  
12      the Secretary of the Interior.

13 **SEC. 3. VETERANS CONSERVATION CORPS.**

14       (a) ESTABLISHMENT.—The Secretary, in cooperation  
15      with the Secretary of Veterans Affairs and the Secretary  
16      of Commerce, shall establish a veterans conservation  
17      corps—

18                   (1) to provide training and employment to eligi-  
19      ble veterans;

20                   (2) to assist eligible veterans in the transition  
21      from service in the Armed Forces to civilian life; and

22                   (3) to assist the Federal Government in main-  
23      taining Federal land and water.

24       (b) EMPLOYMENT OF ELIGIBLE VETERANS.—

25                   (1) LONG-TERM EMPLOYMENT.—

1 (A) INITIAL PERIOD.—The Secretary shall  
2 employ in the corps eligible veterans for a 1-  
3 year period to carry out work projects assigned  
4 under subsection (c).

5 (B) EXTENSION OF EMPLOYMENT.—The  
6 Secretary may, on a case-by-case basis and as  
7 the Secretary considers appropriate, extend the  
8 employment of an eligible veteran under sub-  
9 paragraph (A) for an additional 1-year period.

10 (2) TEMPORARY EMPLOYMENT FOR STUDENT  
11 VETERANS.—

12 (A) IN GENERAL.—The Secretary may es-  
13 tablish a program in the corps for the short-  
14 term employment of eligible veterans that are  
15 attending institutions of higher education.

16 (B) TERMS.—The employment of an eligi-  
17 ble veteran under subparagraph (A) shall not  
18 exceed 16 weeks in total.

19 (3) COMPENSATION.—An eligible veteran em-  
20 ployed by the corps under paragraph (1) or (2) shall  
21 receive a stipend and living allowance in an amount  
22 to be determined by the Secretary, in consultation  
23 with Secretary of Veteran Affairs.

24 (c) WORK PROJECTS.—

1           (1) ASSIGNMENT.—Each eligible veteran em-  
2           ployed under subsection (b)(1) shall be assigned to  
3           a work project that—

4                   (A) furthers the purposes described in sub-  
5           section (a); and

6                   (B) falls within 1 or more of the following  
7           categories:

8                           (i) Transportation improvements, such  
9                           as improving wilderness trails.

10                           (ii) Erosion control.

11                           (iii) Landscape and recreation.

12                           (iv) Habitat protection and restora-  
13                           tion, including removal of invasive species.

14                           (v) Data collection.

15                           (vi) Any other specific project cat-  
16                           egory identified under paragraph (2).

17           (2) SPECIFICATION OF ADDITIONAL PROJECT  
18           CATEGORIES.—Not later than 180 days after the  
19           date of enactment of this Act, the Secretary and the  
20           Secretary of Commerce shall identify additional  
21           project categories that the Secretary and the Sec-  
22           retary of Commerce consider appropriate to further  
23           the purposes described in subsection (a).

24           (3) LEVERAGING OF MILITARY SKILLS.—To the  
25           maximum extent practicable, an eligible veteran in

1 the corps shall be assigned to a work project under  
2 paragraph (1) that enables the eligible veteran to  
3 use the skills that the eligible veteran developed as  
4 a member of the Armed Forces.

5 (4) DEVELOPMENT AND SUPERVISION OF WORK  
6 PROJECTS.—The Secretary and the Secretary of  
7 Commerce shall develop and supervise the work  
8 projects under the corps that relate to the respective  
9 jurisdiction of the Secretary and the Secretary.

10 (d) EDUCATION AND TRAINING.—

11 (1) IN GENERAL.—The Secretary, in coopera-  
12 tion with the Secretary of Veterans Affairs and the  
13 Secretary of Commerce, shall establish a program as  
14 part of the corps to provide to eligible veterans em-  
15 ployed under the corps any education or training  
16 that is necessary to enable the eligible veterans to  
17 carry out the work projects assigned under sub-  
18 section (c)(1).

19 (2) USE OF EXISTING FACILITIES.—To the  
20 maximum extent practicable, the Secretary, the Sec-  
21 retary of Veterans Affairs, and the Secretary of  
22 Commerce shall use existing facilities of the Federal  
23 Government to provide the education and training  
24 required under paragraph (1).
