#### 1 SEC. 2. LOSS MITIGATION PROGRAMS.

2 (a) IN GENERAL.—Section 105 of title 11, United
3 States Code, is amended by adding at the end the fol4 lowing:

"(e) Without limiting the court's authority under 5 subsection (d) or under any other statute or rule, the 6 7 court, by local rule or order, may establish and maintain 8 a loss mitigation program for the consideration and nego-9 tiation of consensual alternatives to avoid foreclosure between an individual debtor and the holder of a claim se-10 11 cured by a security interest in real property that is the debtor's principal residence.". 12

(b) CONFORMING AMENDMENT.—Section 362(e) of
title 11, United States Code, is amended by adding at the
end the following:

16 "(3) If the party in interest requesting relief from the stay under subsection (d) of this section participates 17 in a loss mitigation program maintained pursuant to sec-18 19 tion 105(e) of this title, the time periods specified in paragraphs (1) and (2) of this subsection shall be tolled during 20 21 the time period commencing on the date on which such 22 participation began and ending on the date on which no-23 tice of such termination is filed and served on the debt-24 or.".
