1 **SECTION 1. MIXTURES CONTAINING METHYL 4-({[3-**  
2 **METHOXY-4-METHYL-5-OXO-4,5-DIHYDRO-1H-**  
3 **1,2,4-TRIAZOL-1-YL)CARBONYL]-**  
4 **AMINO}SULFONYL)-5-METHYLTHIOPHENE-3-**  
5 **CARBOXYLATE, ISOXAFLUTOLE, AND**  
6 **CYPROSULFAMIDE.**

7 (a) IN GENERAL.—Subchapter II of chapter 99 of  
8 the Harmonized Tariff Schedule of the United States is  
9 amended by inserting in numerical sequence the following  
10 new heading:

11 (b) EFFECTIVE DATE.—The amendment made by  
12 subsection (a) applies with respect to goods entered, or  
13 withdrawn from warehouse for consumption, on or after  
14 the 15th day after the date of the enactment of this Act.
