## A BILL

To enhance and improve the Yellow Ribbon Reintegration Program of the Department of Defense.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Citizen Soldier Support
- 5 Act".
- 6 SEC. 2. ENHANCEMENT AND IMPROVEMENT OF YELLOW
- 7 RIBBON REINTEGRATION PROGRAM.
- 8 (a) Inclusion of Programs of Outreach in Pro-
- 9 GRAM.—Subsection (b) of section 582 of the National De-
- 10 fense Authorization Act for Fiscal Year 2008 (10 U.S.C.

1	10101 note) is amended by inserting "(including programs
2	of outreach)" after "informational events and activities".
3	(b) RESTATEMENT OF FUNCTIONS OF CENTER FOR
4	EXCELLENCE IN REINTEGRATION AND INCLUSION IN
5	Functions of Identification of Best Practices in
6	PROGRAMS OF OUTREACH.—Subsection (d)(2) of such
7	section, as amended by section 583(b) of the Ike Skelton
8	National Defense Authorization Act for Fiscal Year 2011
9	(Public Law 111–383), is further amended by striking the
10	second, third, and fourth sentences and inserting the fol-
11	lowing: "The Center shall have the following functions:
12	"(A) To collect and analyze 'lessons
13	learned' and suggestions from State National
14	Guard and Reserve organizations with existing
15	or developing reintegration programs.
16	"(B) To assist in developing training aids
17	and briefing materials and training representa-
18	tives from State National Guard and Reserve
19	organizations.
20	"(C) To develop and implement a process
21	for evaluating the effectiveness of the Yellow
22	Ribbon Reintegration Program in supporting
23	the health and well-being of members of the
24	Armed Forces and their families throughout the
25	deployment cycle described in subsection (g).

1 "(D) To develop and implement a process
2 for identifying best practices in the delivery of
3 information and services in programs of out4 reach as described in subsection (j).".

- 5 (c) STATE-LED PROGRAMS OF OUTREACH.—Such 6 section 582 is further amended by adding at the end the 7 following new subsection:
- 8 "(j) State-Led Programs of Outreach.—
- 9 "(1) In General.—The Office for Reintegra-10 tion Programs may work with the States, whether 11 acting through or in coordination with their Na-12 tional Guard and Reserve organizations, to assist 13 the States and such organizations in developing and 14 carrying out programs of outreach for members of 15 the Armed Forces and their families to inform and 16 educate them on the assistance and services avail-17 able to them under the Yellow Ribbon Reintegration 18 Program, including the assistance and services de-19 scribed in subsection (h).
  - "(2) AVAILABILITY OF FUNDS.—From funds available for the Yellow Ribbon Reintegration Program, the Office for Reintegration Programs may provide funds to a State, or a State National Guard and Reserve organization, for the costs of the discharge and enhancement of a program of outreach

- 6 (d) Scope of Activities Under Programs of
- 7 Outreach.—Such section 582 is further amended by
- 8 adding at the end the following new subsection:
- 9 "(k) Scope of Activities Under Programs of
- 10 Outreach.—For purposes of this section, the activities
- 11 and services provided under programs of outreach may in-
- 12 clude personalized and substantive care coordination serv-
- 13 ices targeted specifically to individual members of the
- 14 Armed Forces and their families.".
