A BILL

To amend title I of the Omnibus Crime Control and Safe Streets Act of 1968 to extend the authorization of the Bulletproof Vest Partnership Grant Program through fiscal year 2017.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Bulletproof Vest Part-
3 nership Grant Act of 2012”.

4 **SEC. 2. REAUTHORIZATION.**

5 Section ~~1001(a)(23)~~ of title I of the Omnibus Crime
6 Control and Safe Streets Act of 1968 (42 U.S.C.
7 ~~3793(a)(23)~~) is amended by striking “2012” and inserting
8 “2017”.

9 **SECTION 1. SHORT TITLE.**

10 *This Act may be cited as the “Bulletproof Vest Part-*
11 *nership Grant Program Reauthorization Act of 2012”.*

12 **SEC. 2. EXTENSION OF AUTHORIZATION OF APPROPRIA-**
13 **TIONS FOR BULLETPROOF VEST PARTNER-**
14 **SHIP GRANT PROGRAM.**

15 *Section 1001(a)(23) of title I of the Omnibus Crime*
16 *Control and Safe Streets Act of 1968 (42 U.S.C.*
17 *3793(a)(23)) is amended by striking “part Y,” and all that*
18 *follows and inserting the following: “part Y—*

19 *“(A) \$15,000,000 for each of fiscal years 2013*
20 *and 2014; and*

21 *“(B) \$30,000,000 for each of fiscal years 2015,*
22 *2016, and 2017.”.*

1 **SEC. 3. EXPIRATION OF PREVIOUSLY APPROPRIATED**
2 **FUNDS.**

3 *Section 2501 of title I of the Omnibus Crime Control*
4 *and Safe Streets Act of 1968 (42 U.S.C. 3796ll) is amended*
5 *by adding at the end the following:*

6 *“(h) EXPIRATION OF PREVIOUSLY APPROPRIATED*
7 *FUNDS.—*

8 *“(1) DEFINITION.—In this subsection, the term*
9 *‘previously appropriated funds’ means any amounts*
10 *that—*

11 *“(A) were appropriated for any of fiscal*
12 *years 1999 through 2011 to carry out this part;*
13 *and*

14 *“(B) on the date of enactment of the Bullet-*
15 *proof Vest Partnership Grant Program Reau-*
16 *thorization Act of 2012 are available to be ex-*
17 *pended and have not been expended, including*
18 *funds that were previously obligated but*
19 *undisbursed.*

20 *“(2) EXPIRATION.—All previously appropriated*
21 *funds that are not expended by September 30, 2014,*
22 *shall be transferred to the General Fund of the Treas-*
23 *ury no later than January 15, 2015.”.*

1 **SEC. 4. SENSE OF CONGRESS ON 2-YEAR LIMITATION ON**
2 **FUNDS.**

3 *It is the sense of Congress that amounts made available*
4 *to carry out part Y of title I of the Omnibus Crime Control*
5 *and Safe Streets Act of 1968 (42 U.S.C. 3796ll et seq.)*
6 *should be made available through the end of the first fiscal*
7 *year following the fiscal year for which the amounts are*
8 *appropriated and should not be made available until ex-*
9 *pended.*

10 **SEC. 5. MATCHING FUND LIMITATION.**

11 *Section 2501(f) of title I of the Omnibus Crime Control*
12 *and Safe Streets Act of 1968 (42 U.S.C. 3796ll(f)) is*
13 *amended—*

14 *(1) by redesignating paragraph (3) as para-*
15 *graph (4); and*

16 *(2) inserting after paragraph (2) the following:*

17 *“(3) LIMITATION ON STATE MATCHING FUNDS.—*

18 *A State, unit of local government, or Indian tribe*
19 *may not use funding received under any other Fed-*
20 *eral grant program to pay or defer the cost, in whole*
21 *or in part, of the matching requirement under para-*
22 *graph (1).”.*

1 **SEC. 6. APPLICATION OF BULLETPROOF VEST PARTNER-**
2 **SHIP GRANT PROGRAM REQUIREMENTS TO**
3 **ANY BULLETPROOF VEST OR BODY ARMOR**
4 **PURCHASED WITH FEDERAL GRANT FUNDS.**

5 *Section 521 of title I of the Omnibus Crime Control*
6 *and Safe Streets Act of 1968 (42 U.S.C. 3766a) is amended*
7 *by adding at the end the following:*

8 *“(c) Notwithstanding any other provision of law, a*
9 *grantee that uses funds made available under this part to*
10 *purchase a bulletproof vest or body armor shall comply with*
11 *any requirement established for the use of grants made*
12 *under part Y that an agency receiving funding under part*
13 *Y—*

14 *“(1) have a written policy requiring uniformed*
15 *patrol officers to wear a bulletproof vest or body*
16 *armor; and*

17 *“(2) use the funds to purchase bulletproof vests*
18 *or body armor that meet any performance standards*
19 *established by the Director of the Bureau of Justice*
20 *Assistance.”.*

21 **SEC. 7. UNIQUELY FITTED ARMOR VESTS.**

22 *Section 2501(c) of title I of the Omnibus Crime Con-*
23 *trol and Safe Streets Act of 1968 (42 U.S.C. 3796ll(c)) is*
24 *amended—*

25 *(1) in paragraph (2), by striking “and” at the*
26 *end;*

1 (2) *in paragraph (3), by striking “; or” and in-*
2 *serting “; and”;*

3 (3) *by redesignating paragraph (4) as para-*
4 *graph (5); and*

5 (4) *by inserting after paragraph (3) the fol-*
6 *lowing:*

7 “(4) *provides armor vests to law enforcement of-*
8 *ficers that are uniquely fitted for such officers, includ-*
9 *ing vests uniquely fitted to individual female law en-*
10 *forcement officers; or”.*
