## A BILL

To suspend temporarily the duty on modified aliphatic amine mixtures containing benzyl alcohol, formaldehyde, polymer with 1,3-benzenedimethanamine and phenol, 1,3-benzenedimethanamine, phenol, 4,4'-(1-methylethylidene)bis-, polymer with 2-(chloromethyl)oxirane, reaction products with ethylenediamine.

1 **SECTION 1. MODIFIED ALIPHATIC AMINE MIXTURES CON-**  
2 **TAINING BENZYL ALCOHOL, FORMALDE-**  
3 **HYDE, POLYMER WITH 1,3-**  
4 **BENEZENEDIMETHANAMINE AND PHENOL,**  
5 **1,3-BENEZENEDIMETHANAMINE, PHENOL, 4,4'**  
6 **-(1-METHYLETHYLIDENE)BIS-, POLYMER WITH**  
7 **2-(CHLOROMETHYL)OXIRANE, REACTION**  
8 **PRODUCTS WITH ETHYLENEDIAMINE.**

9 (a) IN GENERAL.—Subchapter II of chapter 99 of  
10 the Harmonized Tariff Schedule of the United States is  
11 amended by inserting in numerical sequence the following  
12 new heading:

“	9902.01.00	Modified aliphatic amine mixtures containing: benzyl alcohol (CAS No. 100–51–6), formaldehyde, polymer with 1,3-benzenedimethanamine and phenol (CAS No. 57214–10–5), 1,3-benzenedimethanamine (CAS No. 1477–55–0), phenol, 4,4'-(1-methylethylidene)bis-, polymer with 2-(chloromethyl)oxirane, reaction products with ethylenediamine (CAS No. 72480–18–3), and ethylenediamine (CAS No. 107–15–3) (provided for in subheading 3909.30.00) ..... 13 (b) EFFECTIVE DATE.—The amendment made by  
14 subsection (a) applies with respect to goods entered, or  
15 withdrawn from warehouse for consumption, on or after
