## A BILL

1 **SECTION 1. OXIRANE, 2-METHYL-, POLYMER WITH**  
2 **OXIRANE, ETHER WITH 1,2,3-PROPANETRIOL**  
3 **(3:1), POLYMER WITH 2,4-DIISOCYANATO-1-**  
4 **METHYLBENZENE AND  $\alpha$ -HYDRO- $\omega$ -**  
5 **HYDROXYPOLY[OXY(METHYL-1,2-**  
6 **ETHANEDIYL)] ETHER WITH 2-ETHYL-2-**  
7 **(HYDROXYMETHYL)-1,3-PROPANEDIOL (3:1),**  
8 **CAPROLACTAM-BLOCKED.**

9 (a) IN GENERAL.—Subchapter II of chapter 99 of  
10 the Harmonized Tariff Schedule of the United States is  
11 amended by inserting in numerical sequence the following  
12 new heading:

“	9902.01.00	Oxirane, 2-methyl-, polymer with oxirane, ether with 1,2,3-propanetriol (3:1), polymer with 2,4-diisocyanato-1-methylbenzene and $\alpha$ -hydro- $\omega$ -hydroxypoly[oxy(methyl-1,2-ethanediyl)] ether with 2-ethyl-2-(hydroxymethyl)-1,3-propanediol (3:1), caprolactam-blocked (CAS No. 127821-00-5) (provided for in subheading 3909.50.50) ..... 13 (b) EFFECTIVE DATE.—The amendment made by  
14 subsection (a) applies with respect to goods entered, or  
15 withdrawn from warehouse for consumption, on or after  
16 the 15th day after the date of the enactment of this Act.
