A BILL

For the relief of Anton Dodaj, Gjyljana Dodaj, Franc Dodaj, and Kristjan Dodaj.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PERMANENT RESIDENT STATUS FOR ANTON
- 4 DODAJ, GJYLJANA DODAJ, FRANC DODAJ,
- 5 AND KRISTJAN DODAJ.
- 6 (a) In General.—Notwithstanding subsections (a)
- 7 and (b) of section 201 of the Immigration and Nationality
- 8 Act (8 U.S.C. 1151), Anton Dodaj, Gjyljana Dodaj, Franc
- 9 Dodaj, and Kristjan Dodaj shall each be eligible for an
- 10 immigrant visa or for adjustment of status to that of an

- 1 alien lawfully admitted for permanent residence upon fil-
- 2 ing an application for issuance of an immigrant visa under
- 3 section 204 of that Act (8 U.S.C. 1154) or for adjustment
- 4 of status to lawful permanent resident.
- 5 (b) Adjustment of Status.—If Anton Dodaj,
- 6 Gjyljana Dodaj, Franc Dodaj, or Kristjan Dodaj enter the
- 7 United States before the filing deadline set forth in sub-
- 8 section (c), Anton Dodaj, Gjyljana Dodaj, Franc Dodaj,
- 9 or Kristjan Dodaj, as appropriate, shall be considered to
- 10 have entered and remained lawfully in the United States
- 11 and shall be eligible for adjustment to lawful permanent
- 12 resident status under section 245 of the Immigration and
- 13 Nationality Act (8 U.S.C. 1255) as of the date of the en-
- 14 actment of this Act.
- 15 (c) Application and Payment of Fees.—Sub-
- 16 sections (a) and (b) shall apply only if the application for
- 17 issuance of an immigrant visa or for adjustment of status
- 18 are filed with appropriate fees not later than 2 years after
- 19 the date of the enactment of this Act.
- 20 (d) Reduction of Immigrant Visa Numbers.—
- 21 Upon granting immigrant visas or lawful permanent resi-
- 22 dent status to Anton Dodaj, Gjyljana Dodaj, Franc Dodaj,
- 23 and Kristjan Dodaj, the Secretary of State shall instruct
- 24 the proper officer to reduce by four, during the current
- 25 or next following fiscal year, the total number of immi-

- 1 grant visas that are made available to natives of the coun-
- 2 try of birth of Anton Dodaj, Gjyljana Dodaj, Franc Dodaj,
- 3 and Kristjan Dodaj under section 202(a)(2) of the Immi-

4 gration and Nationality Act (8 U.S.C. 1152(a)(2)).
