1 **SECTION 1. 1,2-PROPANEDIOL, 3-(DIETHYLAMINO)-, POLY-**
2 **MERS WITH 5-ISOCYANATO-1-**
3 **(ISOCYANATOMETHYL)-1,3,3-**
4 **TRIMETHYLCYCLOHEXANE, PROPYLENE GLY-**
5 **COL AND REDUCED METHYL ESTERS OF RE-**
6 **DUCED POLYMERIZED OXIDIZED**
7 **TETRAFLUROETHYLENE, 2-ETHYL-1-**
8 **HEXANOL-BLOCKED, ACETATES (SALTS).**

9 (a) IN GENERAL.—Subchapter II of chapter 99 of
10 the Harmonized Tariff Schedule of the United States is
11 amended by inserting in numerical sequence the following
12 new heading:

13 (b) EFFECTIVE DATE.—The amendment made by
14 subsection (a) applies with respect to goods entered, or
15 withdrawn from warehouse for consumption, on or after
16 the 15th day after the date of the enactment of this Act.
