Mrs. HAGAN introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To extend the temporary suspension of duty on acrylic filament tow containing 85 percent or more by weight of acrylonitrile units and 2 percent or more but not over 3 percent of water, raw white (undyed), crimped, with an average decitex of 4.1 (plus or minus 10 percent) and an aggregate filament measure in the tow bundle from 660,000 to 1,200,000 decitex, with a length greater than 2 meters.

1 **SECTION 1. ACRYLIC FILAMENT TOW CONTAINING 85 PER-**
 2 **CENT OR MORE BY WEIGHT OF ACRYLO-**
 3 **NITRILE UNITS AND 2 PERCENT OR MORE**
 4 **BUT NOT OVER 3 PERCENT OF WATER, RAW**
 5 **WHITE (UNDYED), CRIMPED, WITH AN AVER-**
 6 **AGE DECITEX OF 4.1 (PLUS OR MINUS 10 PER-**
 7 **CENT) AND AN AGGREGATE FILAMENT MEAS-**
 8 **URE IN THE TOW BUNDLE FROM 660,000 TO**
 9 **1,200,000 DECITEX, WITH A LENGTH GREATER**
 10 **THAN 2 METERS.**

11 (a) IN GENERAL.—Heading 9902.40.12 of the Har-
 12 monized Tariff Schedule of the United States (relating to
 13 acrylic filament tow containing 85 percent or more by
 14 weight of acrylonitrile units and 2 percent or more but
 15 not over 3 percent of water, raw white (undyed), crimped,
 16 with an average decitex of 4.1 (plus or minus 10 percent)
 17 and an aggregate filament measure in the tow bundle from
 18 660,000 to 1,200,000 decitex, with a length greater than
 19 2 meters) is amended by striking the date in the effective
 20 period column and inserting “12/31/2015”.

21 (b) EFFECTIVE DATE.—The amendment made by
 22 subsection (a) applies to goods entered, or withdrawn from
 23 warehouse for consumption, on or after the 15th day after
 24 the date of the enactment of this Act.
