A BILL

To redesignate the Environmental Protection Agency Headquarters located at 1200 Pennsylvania Avenue N.W. in Washington, D.C., as the “William Jefferson Clinton Federal Building”, to redesignate the Federal building and United States Courthouse located at 200 East Wall Street in Midland, Texas, as the “George H.W. Bush and George W. Bush United States Courthouse and

George Mahon Federal Building”, and to designate the Federal building housing the Bureau of Alcohol, Tobacco, Firearms and Explosives Headquarters located at 99 New York Avenue N.E., Washington, D.C., as the “Eliot Ness ATF Building”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Federal Buildings Des-
 5 ignation Act of 2012”.

6 **SEC. 2. ENVIRONMENTAL PROTECTION AGENCY HEAD-**
 7 **QUARTERS.**

8 (a) REDESIGNATION.—The Environmental Protec-
 9 tion Agency Headquarters located at 1200 Pennsylvania
 10 Avenue N.W. in Washington, D.C., known as the Ariel
 11 Rios Building, shall be known and redesignated as the
 12 “William Jefferson Clinton Federal Building”.

13 (b) REFERENCES.—Any reference in a law, map, reg-
 14 ulation, document, paper, or other record of the United
 15 States to the Environmental Protection Agency Head-
 16 quarters referred to in subsection (a) shall be deemed to
 17 be a reference to the “William Jefferson Clinton Federal
 18 Building”.

1 **SEC. 3. GEORGE H.W. BUSH AND GEORGE W. BUSH UNITED**
2 **STATES COURTHOUSE AND GEORGE MAHON**
3 **FEDERAL BUILDING.**

4 (a) REDESIGNATION.—The Federal building and
5 United States Courthouse located at 200 East Wall Street
6 in Midland, Texas, known as the George Mahon Federal
7 Building, shall be known and redesignated as the “George
8 H.W. Bush and George W. Bush United States Court-
9 house and George Mahon Federal Building”.

10 (b) REFERENCES.—Any reference in a law, map, reg-
11 ulation, document, paper, or other record of the United
12 States to the Federal building and United States Court-
13 house referred to in subsection (a) shall be deemed to be
14 a reference to the “George H.W. Bush and George W.
15 Bush United States Courthouse and George Mahon Fed-
16 eral Building”.

17 **SEC. 4. ELIOT NESS ATF BUILDING.**

18 (a) IN GENERAL.—

19 (1) DESIGNATION.—The Federal building hous-
20 ing the Bureau of Alcohol, Tobacco, Firearms and
21 Explosives Headquarters located at 99 New York
22 Avenue N.E. in Washington, D.C., shall be known
23 and designated as the “Eliot Ness ATF Building”.

24 (2) REFERENCES.—Any reference in a law,
25 map, regulation, document, paper, or other record of
26 the United States to the Federal building referred to

1 in paragraph (1) shall be deemed to be a reference
2 to the “Eliot Ness ATF Building”.

3 (b) REFLECTING POOL.—

4 (1) DESIGNATION.—The reflecting pool located
5 on the grounds of the Federal building described in
6 subsection (a) shall be known and designated as the
7 “Ariel Rios Reflecting Pool”.

8 (2) REFERENCES.—Any reference in a law,
9 map, regulation, document, paper, or other record of
10 the United States to the reflecting pool referred to
11 in paragraph (1) shall be deemed to be a reference
12 to the “Ariel Rios Reflecting Pool”.
