Mr. BAUCUS (for himself, Mr. CONRAD, Mr. TESTER, and Mr. JOHNSON of South Dakota) introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

A BILL

To extend supplemental agricultural disaster assistance programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Supplemental Agricul-
5 tural Disaster Assistance Extension Act of 2012”.

6 **SEC. 2. SUPPLEMENTAL AGRICULTURAL DISASTER ASSIST-**
7 **ANCE.**

8 (a) FEDERAL CROP INSURANCE ACT.—Section 531
9 of the Federal Crop Insurance Act (7 U.S.C. 1531) is
10 amended—

1 (1) in subsection (b)(4)—

2 (A) in subparagraph (A)(i)(II), by insert-
 3 ing “the first 5 months of” after “received for”;
 4 and

5 (B) in subparagraph (C), by inserting “the
 6 first 5 months of” after “during the”; and

7 (2) in subsection (i), by striking “2011” and in-
 8 serting “2012”.

9 (b) TRADE ACT OF 1974.—

10 (1) IN GENERAL.—Section 901 of the Trade
 11 Act of 1974 (19 U.S.C. 2497) is amended—

12 (A) in subsection (b)(4)—

13 (i) in subparagraph (A)(i)(II), by in-
 14 serting “the first 5 months of” after “re-
 15 ceived for”; and

16 (ii) in subparagraph (C), by inserting
 17 “the first 5 months of” after “during the”;
 18 and

19 (B) in subsection (i), by striking “2011”
 20 and inserting “2012”.

21 (2) AGRICULTURAL DISASTER RELIEF TRUST
 22 FUND.—Section 902 of the Trade Act of 1974 (19
 23 U.S.C. 2497a) is amended—

24 (A) in subsection (b)(1), by striking
 25 “2011” and inserting “2012”; and

1 (B) in subsection (d), by striking “the
2 Food, Conservation, and Energy Act of 2008”
3 and inserting “Supplemental Agricultural Dis-
4 aster Assistance Extension Act of 2012”.

5 (c) APPLICATION.—The amendments made by this
6 section apply only to losses that are incurred as the result
7 of a disaster, adverse weather, or other environmental con-
8 dition that occurs during the 2012 crop year.
