1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Ensuring Pay for Our

- 4 SEC. 2. EMERGENCY APPROPRIATION OF FUNDS TO PRO-
- 5 VIDE PAY AND ALLOWANCES FOR MEMBERS
- 6 OF THE ARMED FORCES DURING FUNDING
- 7 GAP IMPACTING THE DEPARTMENT OF DE-
- 8 FENSE OR DEPARTMENT OF HOMELAND SE-
- 9 **CURITY.**
- 10 (a) Appropriation of Funds for Military Pay
- 11 AND ALLOWANCES.—During a funding gap impacting the
- 12 Armed Forces, the Secretary of the Treasury shall make
- 13 available to the Secretary of Defense (and the Secretary
- 14 of Homeland Security in the case of the Coast Guard),
- 15 out of any amounts in the general fund of the Treasury
- 16 not otherwise appropriated, such amounts as the Secretary
- 17 of Defense (and the Secretary of Homeland Security in
- 18 the case of the Coast Guard) determines to be necessary
- 19 to continue to provide pay and allowances (without inter-
- 20 ruption) to members of the Army, Navy, Air Force, Ma-
- 21 rine Corps, and Coast Guard, including reserve compo-
- 22 nents thereof, who perform active service during the fund-
- 23 ing gap.
- 24 (b) Funding Gap Defined.—In this section, the
- 25 term "funding gap" means any period of time after the
- 26 beginning of a fiscal year for which interim or full-year

- 1 appropriations for the personnel accounts of the Armed
- 2 Forces for that fiscal year have not been enacted.
- 3 (c) Duration of Transfer Authority.—No
- 4 transfer may be made by the Secretary of the Treasury
- 5 under subsection (a) after December 31, 2011.
