Providing for a conditional recess or adjournment of the Senate and an adjournment of the House of Representatives.

- 1 Resolved by the Senate (the House of Representatives
- 2 concurring), That (a) when the Senate adjourns or re-
- 3 cesses on any day from Wednesday, January 5, 2011,
- 4 through Monday, January 10, 2011, on a motion offered
- 5 pursuant to this concurrent resolution by its majority
- 6 leader or his designee, it stand adjourned or recessed until
- 7 10 a.m. on Tuesday, January 25, 2011, or until the time
- 8 of any reassembly pursuant to section 2 of this concurrent
- 9 resolution, whichever occurs first; and

- 1 (b) when the House adjourns on the legislative day
- 2 of Wednesday, January 12, 2011, on a motion offered
- 3 pursuant to this concurrent resolution by its majority
- 4 leader or his designee, it stand adjourned until 2 p.m. on
- 5 Tuesday, January 18, 2011, or until the time of any re-
- 6 assembly pursuant to section 3 of this concurrent resolu-
- 7 tion, whichever occurs first; and when the House adjourns
- 8 on any legislative day from Wednesday, January 26, 2011,
- 9 through Friday, January 28, 2011, on a motion offered
- 10 pursuant to this concurrent resolution by its majority
- 11 leader or his designee, it stand adjourned until 2 p.m. on
- 12 Tuesday, February 8, 2011, or until the time of any re-
- 13 assembly pursuant to section 3 of this concurrent resolu-
- 14 tion, whichever occurs first.
- 15 Sec. 2. (a) The majority leader of the Senate, or his
- 16 designee, after consultation with the minority leader of the
- 17 Senate, or his designee, shall notify the Members of the
- 18 Senate to reassemble at such place and time as he may
- 19 designate if, in his opinion, the public interest shall war-
- 20 rant it.
- 21 (b) After reassembling pursuant to subsection (a),
- 22 when the Senate recesses or adjourns on a motion offered
- 23 pursuant to this subsection by its majority leader or his
- 24 designee, the Senate shall again stand recessed or ad-

- 1 journed pursuant to the first section of this concurrent
- 2 resolution.
- 3 Sec. 3. The Speaker or his designee, after consulta-
- 4 tion with the minority leader of the House, shall notify
- 5 Members of the House to reassemble at such place and
- 6 time as he may designate if, in his opinion, the public in-
- 7 terest shall warrant it.
