Mr. Akaka, from the Committee on Indian Affairs, reported the following original resolution; which was referred to the Committee on Rules and Administration

RESOLUTION

Authorizing expenditures by the Senate Committee on Indian Affairs.

- 1 Resolved, That, in carrying out its powers, duties, and
- 2 functions imposed by section 105 of S. Res. 4, agreed to
- 3 February 4, 1977 (95th Congress), and in exercising the
- 4 authority conferred on it by that section, the Committee
- 5 on Indian Affairs is authorized from March 1, 2011,
- 6 through September 30, 2011; October 1, 2011, through
- 7 September 30, 2012; and October 1, 2012, through Feb-
- 8 ruary 28, 2013, in its discretion (1) to make expenditures
- 9 from the contingent fund of the Senate, (2) to employ per-
- 10 sonnel, and (3) with the prior consent of the Government

- 1 department or agency concerned and the Committee on
- 2 Rules and Administration, to use on a reimbursable, or
- 3 non-reimbursable, basis the services of personnel of any
- 4 such department or agency.
- 5 Sec. 2. (a) The expenses of the committee for the
- 6 period March 1, 2011, through September 30, 2011,
- 7 under this resolution shall not exceed \$1,482,609, of
- 8 which amount (1) not to exceed \$20,000 may be expended
- 9 for the procurement of the services of individual consult-
- 10 ants, or organizations thereof (as authorized by section
- 11 202(i) of the Legislative Reorganization Act of 1946, as
- 12 amended), and (2) not to exceed \$20,000 may be expended
- 13 for the training of professional staff of such committee
- 14 (under procedures specified by section 202(j) of the Legis-
- 15 lative Reorganization Act of 1946).
- 16 (b) For the period October 1, 2011, through Sep-
- 17 tember 30, 2012, expenses of the committee under this
- 18 resolution shall not exceed \$2,541,614, of which amount
- 19 (1) not to exceed \$20,000 may be expended for the pro-
- 20 curement of the services of individual consultants, or orga-
- 21 nizations thereof (as authorized by section 202(i) of the
- 22 Legislative Reorganization Act of 1946, as amended), and
- 23 (2) not to exceed \$20,000 may be expended for the train-
- 24 ing of professional staff of such committee (under proce-

- 1 dures specified by section 202(j) of the Legislative Reorga-
- 2 nization Act of 1946).
- 3 (c) For the period October 1, 2012, through Feb-
- 4 ruary 28, 2013, expenses of the committee under this res-
- 5 olution shall not exceed \$1,059,007, of which amount (1)
- 6 not to exceed \$20,000 may be expended for the procure-
- 7 ment of the services of individual consultants, or organiza-
- 8 tions thereof (as authorized by section 202(i) of the Legis-
- 9 lative Reorganization Act of 1946, as amended), and (2)
- 10 not to exceed \$20,000 may be expended for the training
- 11 of professional staff of such committee (under procedures
- 12 specified by section 202(j) of the Legislative Reorganiza-
- 13 tion Act of 1946).
- 14 Sec. 3. The committee shall report its findings, to-
- 15 gether with such recommendations for legislation as it
- 16 deems advisable, to the Senate at the earliest practicable
- 17 date, but not later than February 28, 2013.
- 18 Sec. 4. Expenses of the committee under this resolu-
- 19 tion shall be paid from the contingent fund of the Senate
- 20 upon vouchers approved by the chairman of the com-
- 21 mittee, except that vouchers shall not be required (1) for
- 22 the disbursement of the salaries of employees paid at an
- 23 annual rate, or (2) for the payment of telecommunications
- 24 provided by the Office of the Sergeant at Arms and Door-
- 25 keeper, United States Senate, or (3) for the payment of

- 1 stationery supplies purchased through the Keeper of the
- 2 Stationery, United States Senate, or (4) for payments to
- 3 the Postmaster, United States Senate, or (5) for the pay-
- 4 ment of metered charges on copying equipment provided
- 5 by the Office of the Sergeant at Arms and Doorkeeper,
- 6 United States Senate, or (6) for the payment of Senate
- 7 Recording and Photographic Services, or (7) for payment
- 8 of franked and mass mail costs by the Sergeant at Arms
- 9 and Doorkeeper, United States Senate.
- 10 Sec. 5. There are authorized such sums as may be
- 11 necessary for agency contributions related to the com-
- 12 pensation of employees of the committee from March 1,
- 13 2011, through September 30, 2011; October 1, 2011,
- 14 through September 30, 2012; and October 1, 2012,
- 15 through February 28, 2013, to be paid from the Appro-
- 16 priations account for "Expenses of Inquiries and Inves-
- 17 tigations".
