## JOINT RESOLUTION

Making continuing appropriations for certain components of the Department of Homeland Security for fiscal year 2014, and for other purposes.

1       *Resolved by the Senate and House of Representatives*  
2       *of the United States of America in Congress assembled,*  
3       That the following sums are hereby appropriated, out of  
4       any money in the Treasury not otherwise appropriated,  
5       and out of applicable corporate or other revenues, receipts,  
6       and funds, for certain components of the Department of  
7       Homeland Security for fiscal year 2014, and for other pur-  
8       poses, namely:

1        SEC. 101. (a) Such amounts as may be necessary,  
2 at a rate for operations as provided in the Department  
3 of Homeland Security Appropriations Act, 2013 (division  
4 D of Public Law 113–6) and under the authority and con-  
5 ditions provided in such Act, for continuing projects or  
6 activities that are not otherwise specifically provided for  
7 in this joint resolution or in the Pay Our Military Act of  
8 September 30, 2013, that were conducted in fiscal year  
9 2013, and for which appropriations, funds, or other au-  
10 thority were made available by the Department of Home-  
11 land Security Appropriations Act, 2013 (division D of  
12 Public Law 113–6) under the headings “Security, En-  
13 forcement, and Investigations—U.S. Customs and Border  
14 Protection”, “Security, Enforcement, and Investiga-  
15 tions—U.S. Immigration and Customs Enforcement”,  
16 “Security, Enforcement, and Investigations—Coast  
17 Guard”, “Protection, Preparedness, Response, and Recov-  
18 ery—National Protection and Programs Directorate—Of-  
19 fice of Biometric Identity Management”, and “Research  
20 and Development, Training, and Services—United States  
21 Citizenship and Immigration Services”.

22        (b) The rate for operations provided by subsection (a)  
23 for each account shall be calculated to reflect the full  
24 amount of any reduction required in fiscal year 2013 pur-  
25 suant to—

1           (1) any provision of division G of the Consoli-  
2       dated and Further Continuing Appropriations Act,  
3       2013 (Public Law 113–6), including section 3004;  
4       and

5           (2) the Presidential sequestration order dated  
6       March 1, 2013, except as attributable to budget au-  
7       thority made available by the Disaster Relief Appro-  
8       priations Act, 2013 (Public Law 113–2).

9       SEC. 102. Appropriations made by section 101 shall  
10   be available to the extent and in the manner that would  
11   be provided by the pertinent appropriations Act.

12       SEC. 103. Unless otherwise provided for in this joint  
13   resolution or in the applicable appropriations Act for fiscal  
14   year 2014, appropriations and funds made available and  
15   authority granted pursuant to this joint resolution shall  
16   be available until whichever of the following first occurs:  
17   (1) the enactment into law of an appropriation for any  
18   project or activity provided for in this joint resolution; (2)  
19   the enactment into law of the applicable appropriations  
20   Act for fiscal year 2014 without any provision for such  
21   project or activity; or (3) December 15, 2013.

22       SEC. 104. Expenditures made pursuant to this joint  
23   resolution shall be charged to the applicable appropriation,  
24   fund, or authorization whenever a bill in which such appli-

1 cable appropriation, fund, or authorization is contained is  
2 enacted into law.

3 SEC. 105. This joint resolution shall be implemented  
4 so that only the most limited funding action of that per-  
5 mitted in the joint resolution shall be taken in order to  
6 provide for continuation of projects and activities.

7 SEC. 106. Amounts made available under section 101  
8 for civilian personnel compensation and benefits in each  
9 department and agency may be apportioned up to the rate  
10 for operations necessary to avoid furloughs within such de-  
11 partment or agency, consistent with the applicable appro-  
12 priations Act for fiscal year 2013, except that such author-  
13 ity provided under this section shall not be used until after  
14 the department or agency has taken all necessary actions  
15 to reduce or defer non-personnel-related administrative ex-  
16 penses.

17 SEC. 107. It is the sense of Congress that this joint  
18 resolution may also be referred to as the “Border Safety  
19 & Security Act”.

20 This joint resolution may be cited as the “Border Se-  
21 curity and Enforcement Continuing Appropriations Reso-  
22 lution, 2014”.
