## JOINT RESOLUTION

Making continuing appropriations for operations of the United States Military Academy, the United States Naval Academy, the United States Air Force Academy, the Coast Guard Academy, and the United States Merchant Marine Academy for fiscal year 2014.

1       *Resolved by the Senate and House of Representatives*  
2 *of the United States of America in Congress assembled,*  
3 That the following sums are hereby appropriated, out of  
4 any money in the Treasury not otherwise appropriated,  
5 for operations of the United States Military Academy, the  
6 United States Naval Academy, the United States Air  
7 Force Academy, the Coast Guard Academy, and the

1 United States Merchant Marine Academy for fiscal year  
2 2014, and for other purposes, namely:

3       SEC. 101. (a) Such amounts as may be necessary,  
4 at a rate for operations as provided for in the Consolidated  
5 and Further Continuing Appropriations Act, 2013 (Public  
6 Law 113–6) and under the authority and conditions pro-  
7 vided in the applicable divisions of such Act, for projects  
8 or activities for the continuing operations of the United  
9 States Military Academy, the United States Naval Acad-  
10 emy, the United States Air Force Academy, the Coast  
11 Guard Academy, and the United States Merchant Marine  
12 Academy that are not otherwise specifically provided for  
13 in the Pay Our Military Act, that were conducted in fiscal  
14 year 2013, and for which appropriations, funds, or other  
15 authority were made available by the Consolidated and  
16 Further Continuing Appropriations Act, 2013, in the spec-  
17 ified accounts:

18           (1) The United States Military Academy, “De-  
19       partment of Defense—Operation and Maintenance,  
20       Army”.

21           (2) The United States Naval Academy, “De-  
22       partment of Defense—Operation and Maintenance,  
23       Navy”.

1           (3) The United States Air Force Academy,  
2           “Department of Defense—Operation and Maintenance,  
3           Air Force”.

4           (4) The Coast Guard Academy, “Department of  
5           Homeland Security—Coast Guard—Operating Expenses”.

6           (5) The United States Merchant Marine Academy,  
7           “Department of Transportation—Maritime Administration—  
8           Operations and Training”.

9           (b) The rate for operations provided by subsection (a)  
10          for each project or activity shall be calculated to reflect  
11          the full amount of any reduction required in fiscal year  
12          2013 pursuant to—

13           (1) any provision of division G of the Consolidated  
14          and Further Continuing Appropriations Act,  
15          2013 (Public Law 113–6), including section 3004;  
16          and  
17          and

18           (2) the Presidential sequestration order dated  
19          March 1, 2013, except as attributable to budget authority  
20          made available by the Disaster Relief Appropriations Act,  
21          2013 (Public Law 113–2).

22          SEC. 102. Appropriations made by section 101 shall  
23          be available to the extent and in the manner that would  
24          be provided by the pertinent appropriations Act.

1        SEC. 103. Unless otherwise provided for in this joint  
2 resolution or in the applicable appropriations Act for fiscal  
3 year 2014, appropriations and funds made available and  
4 authority granted pursuant to this joint resolution shall  
5 be available until whichever of the following first occurs:  
6 (1) the enactment into law of an appropriation for any  
7 project or activity provided for in this joint resolution; (2)  
8 the enactment into law of the applicable appropriations  
9 Act for fiscal year 2014 without any provision for such  
10 project or activity; or (3) December 15, 2013.

11        SEC. 104. Expenditures made pursuant to this joint  
12 resolution shall be charged to the applicable appropriation,  
13 fund, or authorization whenever a bill in which such appli-  
14 cable appropriation, fund, or authorization is contained is  
15 enacted into law.

16        SEC. 105. This joint resolution shall be implemented  
17 so that only the most limited funding action of that per-  
18 mitted in the joint resolution shall be taken in order to  
19 provide for continuation of projects and activities.

20        This joint resolution may be cited as the “United  
21 States Service Academies Continuing Appropriations Res-  
22 olution, 2014”.
