Mr. BISHOP of Utah introduced the following bill; which was referred to the
Committee on Natural Resources

A BILL

To facilitate the completion of an appropriate national
memorial to Dwight D. Eisenhower.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Dwight D. Eisenhower
5 Memorial Completion Act”.

6 **SEC. 2. DWIGHT D. EISENHOWER MEMORIAL.**

7 (a) AMENDMENTS.—Section 8162 of Public Law
8 106–79 (16 U.S.C. 431 note) is amended as follows:

1 (1) By redesignating subsections (f), (g), (h),
2 (i), (j), (k), (l), and (m) as subsections (g), (h), (i),
3 (j), (k), (l), (m), and (o), respectively.

4 (2) By inserting after subsection (e) the fol-
5 lowing:

6 “(f) TERMS OF MEMBERS.—The appointment of a
7 member of the Commission shall be for a term of 4
8 years.”.

9 (3) In subsection (k), (as so redesignated by
10 paragraph (2))—

11 (A) in paragraph (1), by striking “appro-
12 priated or”;

13 (B) in paragraph (2), by striking “; and”
14 and inserting a semicolon;

15 (C) in paragraph (3), by striking the pe-
16 riod and inserting “; and”; and

17 (D) by adding after paragraph (3) the fol-
18 lowing:

19 “(4) ensure that a design is selected for the me-
20 morial as an alternative to any designs submitted or
21 selected before the date of the enactment of this
22 paragraph.”.

23 (4) By inserting after subsection (m), (as so re-
24 designated by paragraph (2)), the following:

1 “(n) EXPIRATION OF LEGISLATIVE AUTHORITY.—
2 Notwithstanding section 8903(e) of title 40, United States
3 Code, the legislative authority for the memorial shall ex-
4 pire 3 years after the date of the enactment of this sub-
5 section.”.

6 (5) By amending subsection (o), (as so redesign-
7 nated by paragraph (2)), to read as follows:

8 “(o) FUNDING.—No Federal funds may be used to
9 carry out this section.”.

10 (b) EFFECTIVE DATE.—Subsection (f) of section
11 8162 of Public Law 106–79 (16 U.S.C. 431 note), as
12 added by subsection (a) of this Act shall take effect as
13 if enacted on the date of the enactment of Public Law
14 106–79.

15 (c) COMMEMORATIVE WORKS ACT REQUIRE-
16 MENTS.—The text under the heading CAPITAL CONSTRUC-
17 TION in title III of division E of the Consolidated Appro-
18 priations Act, 2012 (40 U.S.C. 8903 note) is amended by
19 striking “expended: *Provided*,” and all that follows
20 through the final period and inserting “expended.”.
