## A BILL

To direct the Secretary of Veterans Affairs to establish a registry of certain veterans who were stationed at or underwent training at Canadian Forces Base Gagetown, New Brunswick, Canada, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. CANADIAN FORCES BASE GAGETOWN REG-**  
4       **ISTRY.**

5       (a) ESTABLISHMENT.—Not later than one year after  
6       the date of the enactment of this Act, the Secretary of

1 Veterans Affairs shall establish and maintain a special  
2 record to be known as the “Canadian Forces Base  
3 Gagetown Health Registry” (in this section referred to as  
4 the “Registry”).

5 (b) CONTENTS.—Except as provided in subsection  
6 (c), the Registry shall include the following information:

7 (1) A list containing the name of each individual who, while serving as a member of the Armed  
8 Forces, was stationed at or underwent training at  
9 Canadian Forces Base Gagetown, New Brunswick,  
10 Canada, at any time during the period beginning  
11 January 1, 1956, and ending on December 31,  
12 2006, and who—

14 (A) applies for care or services from the  
15 Department of Veterans Affairs under chapter  
16 17 of title 38, United States Code;

17 (B) files a claim for compensation under  
18 chapter 11 of such title on the basis of any disability which may be associated with such service;

21 (C) dies and is survived by a spouse, child, or parent who files a claim for dependency and indemnity compensation under chapter 13 of such title on the basis of such service;

1                             (D) requests from the Secretary a health  
2                             examination under subsection (d); or

3                             (E) receives from the Secretary a health  
4                             examination similar to the health examination  
5                             referred to in subparagraph (D) and requests  
6                             inclusion in the Registry.

7                             (2) Relevant medical data relating to the health  
8                             status of, and other information that the Secretary  
9                             considers relevant and appropriate with respect to,  
10                            each individual described in paragraph (1) who—

11                            (A) grants to the Secretary permission to  
12                            include such information in the Registry; or

13                            (B) at the time the individual is listed in  
14                            the Registry, is deceased.

15                             (c) INDIVIDUALS SUBMITTING CLAIMS OR MAKING  
16                             REQUESTS BEFORE DATE OF ENACTMENT.—If in the  
17                             case of an individual described in subsection (b)(1) the  
18                             application, claim, or request referred to in such sub-  
19                             section was submitted, filed, or made, before the date of  
20                             the enactment of this Act, the Secretary shall, to the ex-  
21                             tent feasible, include in the Registry such individual's  
22                             name and the data and information, if any, described in  
23                             subsection (b)(2) relating to the individual.

24                             (d) EXAMINATIONS.—Upon the request of a veteran  
25                             who was stationed at or underwent training at Canadian

1 Forces Base Gagetown at any time during the period be-  
2 ginning January 1, 1956, and ending on December 31,  
3 2006, the Secretary shall provide the veteran with a health  
4 examination (including any appropriate diagnostic tests)  
5 and consultation and counseling with respect to the results  
6 of the examination and the tests.

7 (e) OUTREACH.—

8 (1) ONGOING OUTREACH TO INDIVIDUALS LIST-  
9 ED IN REGISTRY.—The Secretary shall, from time to  
10 time, notify individuals listed in the Registry of sig-  
11 nificant developments in research on the health con-  
12 sequences of potential exposure to a toxic substance  
13 or environmental hazard related to service at Cana-  
14 dian Forces Base Gagetown.

15 (2) EXAMINATION OUTREACH.—The Secretary  
16 shall carry out appropriate outreach activities with  
17 respect to the provision of any health examinations  
18 (including any diagnostic tests) and consultation and  
19 counseling services under subsection (d).

20 (f) DEPARTMENT OF DEFENSE INFORMATION.—The  
21 Secretary of Defense shall furnish to the Secretary of Vet-  
22 erns Affairs such information maintained by the Sec-  
23 retary of Defense as the Secretary of Veterans Affairs con-  
24 siders necessary to establish and maintain the Registry.

1       (g) ANNUAL REPORT.—Not later than two years  
2 after the date of the enactment of this Act, and each year  
3 thereafter, the Secretary of Veterans Affairs shall submit  
4 to the Committees on Veterans' Affairs of the House of  
5 Representatives and the Senate a report on the Registry,  
6 including—

7                 (1) the number of veterans included in the Reg-  
8 istry;

9                 (2) any trends that exist with respect to vet-  
10 erns included in the Registry and claims for com-  
11 pensation under chapters 11 or 13 of title 38,  
12 United States Code;

13                 (3) a description of the outreach efforts made  
14 by the Secretary under subsection (e) during the pe-  
15 riod covered by the report; and

16                 (4) such other information as the Secretary  
17 considers appropriate.
