A BILL

To authorize the Administrator of the National Oceanic and
Atmospheric Administration to provide certain funds to
eligible entities for activities undertaken to address the
marine debris impacts of the March 2011 Tohoku earth-
quake and subsequent tsunami, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. AUTHORITY TO PROVIDE FUNDS.**

2 (a) IN GENERAL.—Notwithstanding any other provi-
3 sion of law, the Administrator of the National Oceanic and
4 Atmospheric Administration may provide funds to an eligi-
5 ble entity impacted by the covered marine debris event to
6 assist such entity with the costs of any activity previously
7 carried out, being carried out, or to be carried out to ad-
8 dress the effects of such event.

9 (b) FUNDING.—The Administrator may provide
10 funds under subsection (a) using any funds provided by
11 the Government of Japan for activities to address the ef-
12 fects of the covered marine debris event.

13 (c) DEFINITIONS.—In this section, the following defi-
14 nitions apply:

15 (1) COVERED MARINE DEBRIS EVENT.—The
16 term “covered marine debris event” means the
17 events, including marine debris, resulting from the
18 March 2011 Tohoku earthquake and subsequent tsu-
19 nami.

20 (2) ELIGIBLE ENTITY.—The term “eligible enti-
21 ty” means any State, local, or tribal government.
