2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Multispecies Habitat
5 Conservation Plan Implementation Act”.

1 **SEC. 2. IMPLEMENTATION OF MULTISPECIES HABITAT**
 2 **CONSERVATION PLANS.**

3 (a) VIRGIN RIVER, NEVADA.—Section 3(d)(3)(B) of
 4 Public Law 99–548 (100 Stat. 3061, 116 Stat. 2018) is
 5 amended by inserting “and implementation” after “devel-
 6 opment”.

7 (b) LINCOLN COUNTY, NEVADA.—Section 5(b)(1)(B)
 8 of the Lincoln County Land Act of 2000 (Public Law
 9 106–298; 114 Stat. 1048), is amended by inserting “and
 10 implementation” after “development”.

11 **SEC. 3. EXTENSION OF PURCHASE AUTHORITY AND WITH-**
 12 **DRAWALS.**

13 Section 3 of Public Law 99–548 (100 Stat. 3061,
 14 113 Stat. 1501A–166) is amended—

15 (1) in subsection (e)—

16 (A) in paragraph (1)(A), by striking “For
 17 a period of 12 years after the date of the enact-
 18 ment of this Act” and inserting “Until Novem-
 19 ber 29, 2021”;

20 (B) in paragraph (3), by striking “Not
 21 later than 10 years after the date of the enact-
 22 ment of this subsection” and inserting “Not
 23 later than November 29, 2021”; and

24 (C) in paragraph (5), by striking “the date
 25 that is 12 years after the date of the enactment

1 of this subsection” and inserting “November
2 29, 2021”; and
3 (2) in subsection (f)(3), by striking “the date
4 that is 12 years after the date of the enactment of
5 this subsection” and inserting “November 29,
6 2021”.
