A BILL

To establish biennial budgets for the United States
Government.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Biennial Budgeting
 5 and Enhanced Oversight Act of ~~2013~~ 2014”.

6 **TITLE I—CONGRESSIONAL**
 7 **BUDGET PROCESS**

8 **SEC. 101. PURPOSES.**

9 Paragraphs (1) and (2) of section 2 of the Congres-
 10 sional Budget and Impoundment Control Act of 1974 are
 11 amended to read as follows:

12 “(1) to assure effective control over the budg-
 13 etary process;

14 “(2) to facilitate the determination biennially of
 15 the appropriate level of Federal revenues and ex-
 16 penditures by the Congress and the President;”.

17 **SEC. 102. DEFINITIONS.**

18 Section 3 of the Congressional Budget *and Impound-*
 19 *ment Control* Act of 1974 is amended by adding at the
 20 end the following new paragraphs:

21 “(12) The term ‘direct spending’ has the mean-
 22 ing given to such term in section 250(c)(8) of the
 23 Balanced Budget and Emergency Deficit Control
 24 Act of 1985.

1 “(13) The term ‘biennium’ means the period of
 2 2 consecutive fiscal years beginning on October 1 of
 3 any odd-numbered year.”.

4 **SEC. 103. REVISION OF TIMETABLE.**

5 Section 300 of the Congressional Budget Act of 1974
 6 (2 U.S.C. 631) is amended to read as follows:

7 “TIMETABLE

8 “SEC. 300. The timetable with respect to the congres-
 9 sional budget process for any Congress (beginning with
 10 the One Hundred ~~Fourteenth~~ *Fifteenth* Congress) is as fol-
 11 lows:

President submits budget recommendations.

 Budget Committees report concurrent resolu-

 Biennial appropriation bills may be consid-

1 **SEC. 104. BIENNIAL CONCURRENT RESOLUTIONS ON THE**
2 **BUDGET.**

3 (a) CONTENTS OF RESOLUTION.—Section 301(a) of
4 the Congressional Budget Act of 1974 (2 U.S.C. 632(a))
5 is amended—

6 (1) in the matter preceding paragraph (1), by—

7 (A) striking “April 15 of each year” and
8 inserting “April 15 of each odd-numbered
9 year”;

10 (B) striking “the fiscal year beginning on
11 October 1 of such year” the first place it ap-
12 pears and inserting “the biennium beginning on
13 October 1 of such year”;

14 (C) striking “the fiscal year beginning on
15 October 1 of such year” the second place it ap-
16 pears and inserting “each fiscal year in such
17 period”; and

18 (D) striking “each of the ~~four~~ 4 ensuing
19 fiscal years” and inserting “each fiscal year in
20 the next 2 bienniums”;

21 (2) by striking paragraph (4) and inserting the
22 following:

23 “(4) subtotals of new budget authority and out-
24 lays for nondefense discretionary spending, defense
25 discretionary spending, Medicare, Medicaid and

1 other health-related spending, other direct spending
 2 (excluding interest), and net interest;”;

3 (3) in paragraph (6), by striking “for the fiscal
 4 year” and inserting “for each fiscal year in the bien-
 5 nium”; and

6 (4) in paragraph (7), by striking “for the fiscal
 7 year” and inserting “for each fiscal year in the bien-
 8 nium”.

9 (b) ADDITIONAL MATTERS IN CONCURRENT RESO-
 10 LUTION.—Section 301(b) of the Congressional Budget Act
 11 of 1974 is amended—

12 (1) by striking paragraph (1), and by striking
 13 paragraphs (6) through (9);

14 (2) by redesignating paragraphs (2), (3), (4),
 15 and (5) as paragraphs (1), (2), (3), and (4), respec-
 16 tively;

17 (3) in paragraph (2), as redesignated, by strik-
 18 ing “for such fiscal year” and inserting “for either
 19 fiscal year in such biennium”; ~~and~~

20 (4) by striking paragraph (3), as redesignated,
 21 and inserting the following:

22 “(3) set forth such other matters, and require
 23 such other procedures, relating to the budget as may
 24 be appropriate to carry out the purposes of the Act,
 25 but shall not include a suspension or alteration of

1 the application of the motion to strike a provision as
 2 set forth in section 310(d)(2) or (h)(2)(F);”*;* and
 3 (5) in paragraph (4), as redesignated, by strik-
 4 ing the semicolon and inserting a period.

5 (c) VIEWS OF OTHER COMMITTEES.—Section 301(d)
 6 of the Congressional Budget Act of 1974 (2 U.S.C.
 7 632(d)) is amended by adding at the end the following
 8 new sentences: “Each committee of the Senate or the
 9 House of Representatives shall review the strategic plans,
 10 performance plans, and performance reports required
 11 under section 306 of title 5, United States Code, and sec-
 12 tions 1115 and 1116 of title 31, United States Code, of
 13 all agencies under the jurisdiction of the committee. Each
 14 committee may provide its views on such plans or reports
 15 to the Committee on the Budget of the applicable House.”.

16 (d) HEARINGS AND REPORT.—Section 301(e) of the
 17 Congressional Budget Act of 1974 (2 U.S.C. 632(e)) is
 18 amended—

19 (1) in paragraph (1)—

20 (A) by striking “fiscal year” and inserting
 21 “biennium”; and

22 (B) by inserting after the second sentence
 23 the following: “On or before April 1 of each
 24 odd-numbered year, the Committee on the
 25 Budget of each House shall report to its House

1 the concurrent resolution on the budget referred
2 to in subsection (a) for the biennium beginning
3 on October 1 of that year.”;

4 (2) in paragraph (2)—

5 (A) by redesignating subparagraphs (A),
6 (B), (C), (D), (E), and (F) as subparagraphs
7 (B), (C), (E), (F), (H), and (I), respectively;

8 (B) before subparagraph (B) (as redesign-
9 nated), by inserting the following new subpara-
10 graph:

11 “(A) new budget authority and outlays for
12 each major functional category, based on alloca-
13 tions of the total levels set forth pursuant to
14 subsection (a)(1);”;

15 (C) in subparagraph (C) (as redesignated),
16 by striking “mandatory” and inserting “direct
17 spending”;

18 (D) after subparagraph (C) (as redesign-
19 nated), by inserting the following new subpara-
20 graph:

21 “(D) total outlays, total Federal revenues,
22 the surplus or deficit, and new budget authority
23 and outlays for nondefense discretionary spend-
24 ing, defense discretionary spending, Medicare,
25 Medicaid and other health-related spending,

1 other direct spending (excluding interest), social
2 security and other major functional categories,
3 as appropriate, and net interest as set forth in
4 such resolution as a percentage of the gross do-
5 mestic product of the United States;” and

6 (E) after subparagraph (F) (as redesign-
7 nated), by inserting the following new subpara-
8 graph:

9 “(G) if the concurrent resolution on the
10 budget includes any allocation to a committee
11 other than the Committee on Appropriations of
12 levels in excess of current law levels, a justifica-
13 tion for not subjecting any program, project, or
14 activity (for which the allocation is made) to
15 annual discretionary appropriations;” and

16 (3) in paragraph (3)—

17 (A)(i) by redesignating subparagraphs (A)
18 and (B) as subparagraphs (B) and (C), respec-
19 tively;

20 (ii) by striking subparagraphs (C) and (D);

21 (iii) by redesignating subparagraph (E) as
22 subparagraph (D); and

23 (iv) by striking the period and the end of
24 subparagraph (D), as redesignated, and insert-
25 ing “; and”;

1 (B) before subparagraph (B), *as redesign-*
 2 *nated*, by inserting the following new subpara-
 3 graph:

4 “(A) new budget authority and outlays for
 5 each major functional category, based on alloca-
 6 tions of the total levels set forth pursuant to
 7 subsection (a)(1);” and

8 (C) at the end, by adding the following
 9 new subparagraph:

10 “(E) set forth, if required by subsection
 11 (f), the calendar year in which, in the opinion
 12 of the Congress, the goals for reducing unem-
 13 ployment set forth in section 4(b) of the Em-
 14 ployment Act of 1946 should be achieved.”.

15 (e) GOALS FOR REDUCING UNEMPLOYMENT.—Sec-
 16 tion 301(f) of the Congressional Budget Act of 1974 (2
 17 U.S.C. 632(f)) is amended by striking “fiscal year” each
 18 place it appears and inserting “biennium”.

19 (f) ECONOMIC ASSUMPTIONS.—Section 301(g)(1) of
 20 the Congressional Budget Act of 1974 (2 U.S.C.
 21 632(g)(1)) is amended by striking “for a fiscal year” and
 22 inserting “for a biennium”.

23 (g) SECTION HEADING.—The section heading of sec-
 24 tion 301 of the Congressional Budget Act of 1974 is

1 amended by striking “ANNUAL” and inserting “BIEN-
2 NIAL”.

3 (h) TABLE OF CONTENTS.—The item relating to sec-
4 tion 301 in the table of contents set forth in section 1(b)
5 of the Congressional Budget *and Impoundment Control*
6 Act of 1974 is amended by striking “Annual” and insert-
7 ing “Biennial”.

8 **SEC. 105. COMMITTEE ALLOCATIONS.**

9 Section 302 of the Congressional Budget Act of 1974
10 (2 U.S.C. 633) is amended—

11 (1) in subsection (a)(1) by—

12 (A) striking “for the first fiscal year of the
13 resolution,” and inserting “for each fiscal year
14 in the biennium,”;

15 (B) striking “for that period of fiscal
16 years” and inserting “for all fiscal years cov-
17 ered by the resolution”; and

18 (C) striking “for the fiscal year of that
19 resolution” and inserting “for each fiscal year
20 in the biennium”;

21 (2) in the first sentence of subsection (b), by
22 striking “subsection (a)” and inserting “subsection
23 (a)(1)”;

24 (3) in subsection (f)(1)—

1 (A) by striking “for a fiscal year” and in-
 2 serting “for a biennium”;

3 (B) by striking “*the* first fiscal year” and
 4 inserting “either fiscal year of the biennium”;
 5 and

6 (C) in subparagraph (A), by striking “as
 7 reported”;

8 (4) in subsection (f)(2)(A), by—

9 (A) striking “first fiscal year” and insert-
 10 ing “each fiscal year of the biennium”; and

11 (B) striking “the total of fiscal years” and
 12 inserting “the total of all fiscal years covered by
 13 the resolution”; and

14 (5) by striking subsection (g).

15 **SEC. 106. MULTIYEAR AUTHORIZATIONS OF APPROPRIA-**
 16 **TIONS.**

17 (a) IN GENERAL.—Title III of the Congressional
 18 Budget Act of 1974 is amended by adding after section
 19 315 the following new section:

20 “MULTIYEAR AUTHORIZATIONS OF APPROPRIATIONS

21 “SEC. 316. (a) It shall not be in order in the House
 22 of Representatives or the Senate to consider any measure
 23 that contains an authorization of appropriations for any
 24 purpose unless the measure includes such an authorization
 25 of appropriations for that purpose for not less than each
 26 fiscal year in one or more bienniums.

1 “(b)(1) For purposes of this section, an authorization
2 of appropriations is an authorization for the enactment
3 of an amount of appropriations or amounts not to exceed
4 an amount of appropriations (whether stated as a sum cer-
5 tain, as a limit, or as such sums as may be necessary)
6 for any purpose for a fiscal year.

7 “(2) Subsection (a) does not apply with respect to
8 an authorization of appropriations for a single fiscal year
9 for any program, project, or activity if the measure con-
10 taining that authorization includes a provision expressly
11 stating the following: ‘Congress finds that no authoriza-
12 tion of appropriation will be required for [Insert name of
13 applicable program, project, or activity] for any subse-
14 quent fiscal year.’.

15 “(c) For purposes of this section, the term ‘measure’
16 means a bill, joint resolution, amendment, motion, or con-
17 ference report.”.

18 (b) CONFORMING AMENDMENT.—The table of con-
19 tents set forth in section 1(b) of the Congressional Budget
20 and Impoundment Control Act of 1974 is amended by in-
21 serting after the item relating to section 315 the following
22 new item:

“Sec. 316. Multiyear authorizations of appropriations.”.

1 **SEC. 107. ADDITIONAL AMENDMENTS TO THE CONGRES-**
 2 **SIONAL BUDGET ACT OF 1974 TO EFFEC-**
 3 **TUATE BIENNIAL BUDGETING.**

4 (a) DEFINITIONS.—Section 3 of the Congressional
 5 Budget and Impoundment Control Act of 1974 ~~is amend-~~
 6 ~~ed~~, *as amended, is further amended* by adding at the end
 7 the following new paragraphs:

8 “~~(12)~~ (14) The term ‘Medicare’ means pro-
 9 grams within budget function 570.

10 “~~(13)~~ (15) The term ‘Medicaid and other
 11 health-related spending’ means programs within
 12 budget function 550.

13 “~~(14)~~ (16) The term ‘other direct spending’
 14 means programs other than those within budget
 15 functions 550 and 570, excluding Social Security
 16 and net interest.”.

1 (4) by striking “that year” and inserting “each
2 odd-numbered year”.

3 (c) COMPLETION OF HOUSE ACTION ON REGULAR
4 APPROPRIATION BILLS.—Section 309 of the Congres-
5 sional Budget Act of 1974 (2 U.S.C. 640) is amended—

6 (1) by inserting “of any odd-numbered calendar
7 year” after “July”;

8 (2) by striking “annual” and inserting “bien-
9 nial”; and

10 (3) by striking “fiscal year” and inserting “bi-
11 ennium”.

12 (d) RECONCILIATION PROCESS.—Section 310 of the
13 Congressional Budget Act of 1974 (2 U.S.C. 641) is
14 amended—

15 (1) in subsection (a), in the matter preceding
16 paragraph (1), by striking “any fiscal year” and in-
17 serting “any biennium”;

18 (2) in subsection (a)(1), by striking “such fiscal
19 year” each place it appears and inserting “any fiscal
20 year covered by such resolution”; and

21 (3) by striking subsection (f) and redesignating
22 subsection (g) as subsection (f).

23 (e) SECTION 311 POINT OF ORDER.—

1 (1) IN THE HOUSE OF REPRESENTATIVES.—
2 Section 311(a)(1) of the Congressional Budget Act
3 of 1974 (2 U.S.C. 642(a)) is amended—

4 (A) by striking “for a fiscal year” and in-
5 serting “for a biennium”;

6 (B) by striking “the first fiscal year” each
7 place it appears and inserting “either fiscal
8 year of the biennium”; and

9 (C) by striking “that first fiscal year” and
10 inserting “each fiscal year in the biennium”.

11 (2) IN THE SENATE.—Section 311(a)(2) of the
12 Congressional Budget Act of 1974 is amended—

13 (A) in subparagraph (A), by striking “for
14 the first fiscal year” and inserting “for either
15 fiscal year of the biennium”; and

16 (B) in subparagraph (B)—

17 (i) by striking “that first fiscal year”
18 the first place it appears and inserting
19 “each fiscal year in the biennium”; and

20 (ii) by striking “that first fiscal year
21 and the ensuing fiscal years” and inserting
22 “all fiscal years”.

23 (3) SOCIAL SECURITY LEVELS.—Section
24 311(a)(3) of the Congressional Budget Act of 1974
25 is amended by—

1 (A) striking “for the first fiscal year” and
2 inserting “each fiscal year in the biennium”;
3 and

4 (B) striking “that fiscal year and the ensu-
5 ing fiscal years” and inserting “all fiscal
6 years”.

7 (4) EXCEPTION.—Section 311(c) of the Con-
8 gressional Budget Act of 1974 is amended by insert-
9 ing “with respect to new budget authority or out-
10 lays” after “shall not apply”.

11 (f) MAXIMUM DEFICIT AMOUNT POINT OF ORDER.—
12 Section 312(c) of the Congressional Budget Act of 1974
13 (2 U.S.C. 643) is amended—

14 (1) by striking “for a fiscal year” and inserting
15 “for a biennium”;

16 (2) in paragraph (1), by striking “first fiscal
17 year” and inserting “either fiscal year in the bien-
18 nium”;

19 (3) in paragraph (2), by striking “that fiscal
20 year” and inserting “either fiscal year in the bien-
21 nium”; and

22 (4) in the matter following paragraph (2), by
23 striking “that fiscal year” and inserting “the appli-
24 cable fiscal year”.

9 **SEC. 201. AMENDMENTS TO THE RULES OF THE HOUSE OF**
 10 **REPRESENTATIVES TO EFFECTUATE BIEN-**
 11 **NIAL BUDGETING.**

12 (a) Clause 2(a) of rule XXI of the Rules of the House
 13 of Representatives is amended by adding at the end the
 14 following new subparagraph:

15 “(3)(A) Except as provided by subdivision (B), an ap-
 16 propriation may not be reported in a general appropriation
 17 bill (other than a supplemental appropriation bill), and
 18 may not be in order as an amendment thereto, unless it
 19 provides new budget authority or establishes a level of ob-
 20 ligations under contract authority for each fiscal year of
 21 a biennium.

22 “(B) Subdivision (A) does not apply with respect to
 23 an appropriation for a single fiscal year for any program,
 24 project, or activity if the bill or amendment thereto con-
 25 taining that appropriation includes a provision expressly

1 stating the following: ‘Congress finds that no additional
2 funding beyond one fiscal year will be required and the
3 [Insert name of applicable program, project, or activity]
4 will be completed or terminated after the amount provided
5 has been expended.’.

6 “(C) For purposes of paragraph (b), the statement
7 set forth in subdivision (B) with respect to an appropria-
8 tion for a single fiscal year for any program, project, or
9 activity may be included in a general appropriation bill
10 or amendment thereto.”.

11 (b) Clause 4(a)(1)(A) of rule X of the Rules of the
12 House of Representatives is amended by inserting “odd-
13 numbered” after “each”.

14 (c) Clause 4(a)(4) of rule X of the Rules of the House
