A BILL

To amend the Internal Revenue Code of 1986 to repeal
the phasedown of the credit percentage for the dependent
care tax credit.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Support Working Par-
5 ents Act of 2013”.

6 **SEC. 2. REPEAL OF PHASEDOWN OF CREDIT PERCENTAGE**
7 **FOR DEPENDENT CARE CREDIT.**

8 (a) IN GENERAL.—Subsection (a) of section 21 of the
9 Internal Revenue Code of 1986 (relating to expenses for

1 household and dependent care services necessary for gain-
2 ful employment) is amended to read as follows:

3 “(a) ALLOWANCE OF CREDIT.—In the case of an in-
4 dividual for which there are 1 or more qualifying individ-
5 uals with respect to such individual, there shall be allowed
6 as a credit against the tax imposed by this chapter for
7 the taxable year an amount equal to 35 percent of the
8 employment-related expenses paid by such individual dur-
9 ing the taxable year.”.

10 (b) EFFECTIVE DATE.—The amendment made by
11 this section shall apply to taxable years beginning after
12 the date of the enactment of this Act.
