Mr. CRAWFORD (for himself, Mr. COTTON, Mr. GRIFFIN of Arkansas, and Mr. WOMACK) introduced the following bill; which was referred to the Committee on Oversight and Government Reform

A BILL

To create a centralized website on reports issued by the
Inspectors General, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Sunshine on Govern-
5 ment Act of 2013”.

6 **SEC. 2. WEBSITE FOR AUDIT REPORTS.**

7 (a) IN GENERAL.—Not later than 90 days after the
8 date of the enactment of this Act, the Director of the Of-
9 fice of Management and Budget, in consultation with the
10 Executive Chair of the Council of the Inspectors General

1 on Integrity and Efficiency, shall create a separate website
2 with a distinct URL, that is not under the website of the
3 Office of Management and Budget, about the reports
4 issued by each Office of Inspector General.

5 (b) CONTENTS.—The website in subsection (a) shall
6 include the following:

7 (1) A general description of the role of the Of-
8 fice of Inspector General.

9 (2) A description of the types of reports gen-
10 erally issued by the Offices of Inspector General, in-
11 cluding the purpose, composition, and process used
12 to create such reports.

13 (3) A list of each Federal agency or other Fed-
14 eral entity that has an Office of Inspector General
15 and the name and office telephone number for each
16 Inspector General.

17 (4) For each agency or entity listed in para-
18 graph (3), a link to the page of the website through
19 which inspector general reports of such agency or
20 entity can be obtained, including audit reports, man-
21 agement deficiency reports, and the semiannual re-
22 ports submitted to Congress pursuant to section 5 of
23 the Inspector General Act of 1978 (5. U.S.C. App.).

24 (c) UPDATE TO WEBSITE.—The Director of the Of-
25 fice of Management and Budget shall update the website

1 created pursuant to subsection (a) in a timely manner, en-
2 suring that the information, links to other websites, and
3 contact information are correct.

4 (d) FEDERAL AGENCY DEFINED.—In this section,
5 the term “Federal agency” has the meaning given that
6 term in section 12 of the Inspector General Act of 1978
7 (5 U.S.C. App.).
