3 **SECTION 1. REAUTHORIZATION OF NATIONAL HERITAGE**

4 **AREAS AND CORRIDOR.**

5 (a) RIVERS OF STEEL NATIONAL HERITAGE
6 AREA.—Section 408 of the Steel Industry American Her-
7 itage Area Act of 1996 (Public Law 104–333; 110 Stat.

1 4256; 127 Stat. 420) is amended by striking “2013” and
 2 inserting “2023”.

3 (b) LACKAWANNA VALLEY NATIONAL HERITAGE
 4 AREA.—Section 108 of the Lackawanna Valley National
 5 Heritage Area Act of 2000 (Public Law 106–278; 114
 6 Stat. 818; 127 Stat. 420) is amended by striking “2013”
 7 and inserting “2023”.

8 (c) DELAWARE AND LEHIGH NATIONAL HERITAGE
 9 CORRIDOR.—Section 12 of the Delaware and Lehigh
 10 Navigation Canal National Heritage Corridor Act of 1988
 11 (Public Law 100–692; 102 Stat. 4558; 112 Stat. 3260;
 12 123 Stat. 1293; 127 Stat. 420) is amended—

13 (1) in subsection (c)(1), by striking “2013” and
 14 inserting “2023”; and

15 (2) in subsection (d), by striking “2013” and
 16 inserting “2023”.

17 (d) SCHUYLKILL RIVER VALLEY NATIONAL HERIT-
 18 AGE AREA.—Section 209 of the Schuylkill River Valley
 19 National Heritage Area Act (Public Law 106–278; 114
 20 Stat. 824) is amended by striking “the date that is 15
 21 years after the date of enactment of this title” and insert-
 22 ing “September 30, 2023”.
