## A BILL

To modify the boundary of Petersburg National Battlefield in the Commonwealth of Virginia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PETERSBURG NATIONAL BATTLEFIELD BOUND-**  
4 **ARY MODIFICATION.**

5 (a) IN GENERAL.—The boundary of the Petersburg  
6 National Battlefield is modified to include the land and  
7 interests in land as generally depicted on the map titled  
8 “Petersburg National Battlefield Boundary Expansion”,  
9 numbered 325/80,080, and dated June 2007. The map

1 shall be on file and available for public inspection in the  
2 appropriate offices of the National Park Service.

3 (b) ACQUISITION OF PROPERTIES.—The Secretary of  
4 the Interior (referred to in this section as the “Secretary”)  
5 is authorized to acquire the land and interests in land,  
6 described in subsection (a), from willing sellers only, by  
7 donation, purchase with donated or appropriated funds,  
8 exchange, or transfer.

9 (c) ADMINISTRATION.—The Secretary shall admin-  
10 ister any land or interests in land acquired under sub-  
11 section (b) as part of the Petersburg National Battlefield  
12 in accordance with applicable laws and regulations.

13 (d) ADMINISTRATIVE JURISDICTION TRANSFER.—

14 (1) IN GENERAL.—There is transferred—

15 (A) from the Secretary to the Secretary of  
16 the Army administrative jurisdiction over the  
17 approximately 1.170-acre parcel of land de-  
18 picted as “Area to be transferred to Fort Lee  
19 Military Reservation” on the map described in  
20 paragraph (2); and

21 (B) from the Secretary of the Army to the  
22 Secretary administrative jurisdiction over the  
23 approximately 1.171-acre parcel of land de-  
24 picted as “Area to be transferred to Petersburg

1 National Battlefield” on the map described in  
2 paragraph (2).

3 (2) MAP.—The land to be exchanged is de-  
4 picted on the map titled “Petersburg National Bat-  
5 tlefield Proposed Transfer of Administrative Juris-  
6 diction”, numbered 325/80,801A, dated May 2011.  
7 The map shall be on file and available for public in-  
8 spection in the appropriate offices of the National  
9 Park Service.

10 (3) CONDITIONS OF TRANSFER.—The transfer  
11 of administrative jurisdiction under paragraph (1)  
12 shall be subject to the following conditions:

13 (A) NO REIMBURSEMENT OR CONSIDER-  
14 ATION.—The transfer shall occur without reim-  
15 bursement or consideration.

16 (B) MANAGEMENT.—The land conveyed to  
17 the Secretary under paragraph (1) shall be in-  
18 cluded within the boundary of the Petersburg  
19 National Battlefield and shall be administered  
20 as part of that park in accordance with applica-  
21 ble laws and regulations.
