Ms. KELLY of Illinois introduced the following bill; which was referred to the Committee on Education and the Workforce

A BILL

To amend the Elementary and Secondary Education Act of 1965 to authorize the use of funds for the inclusion in domestic violence education programs of information on legal rights available to teenage victims of dating violence.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Teen Dating Violence
5 Education Act of 2013”.

6 **SEC. 2. FINDINGS.**

7 The Congress finds as follows:

1 (1) Girls and women between the ages of 16
2 and 24 are the most vulnerable to domestic violence,
3 experiencing the highest per capita rates of non-fatal
4 intimate partner violence.

5 (2) One-third of teens report experiencing some
6 kind of abuse in their romantic relationships, includ-
7 ing verbal and emotional abuse.

8 (3) Approximately 1 in 5 adolescent girls report
9 being physically or sexually hurt by a dating part-
10 ner.

11 (4) Forty percent of teenage girls ages 14 to 17
12 report knowing someone their age who has been hit
13 or beaten by a boyfriend.

14 (5) Twenty-six percent of girls in grades 9 to
15 12 have been the victim of physical abuse, sexual
16 abuse, or date rape.

17 (6) Teenagers who are the victims of dating vio-
18 lence often do not know the legal actions they can
19 take to put an end to the violence they are experi-
20 encing. These teenagers often do not inquire into
21 legal actions they can take because of the perceived
22 stigma of dating violence.

23 (7) The cost of intimate partner violence annu-
24 ally exceeds \$5.8 billion, including \$4.1 billion in di-
25 rect health care expenses.

1 (8) Domestic violence has been estimated to
2 cost employers in the United States up to \$13 billion
3 each year.

4 (9) In the United States, rape is the most cost-
5 ly crime to its victims, totaling \$127 billion a year,
6 including medical costs, lost earnings, pain, suf-
7 fering, and lost quality of life

8 **SEC. 3. INCLUSION IN DOMESTIC VIOLENCE EDUCATION**

9 **PROGRAMS OF INFORMATION ON LEGAL**
10 **RIGHTS AVAILABLE TO TEENAGE VICTIMS OF**
11 **DATING VIOLENCE.**

12 Paragraph (2) of section 5571(c) of the Elementary
13 and Secondary Education Act of 1965 (20 U.S.C.
14 7275(c)) is amended—

15 (1) by striking “and are designed” and insert-
16 ing “, are designed”; and

17 (2) by inserting “, and include information spe-
18 cific to the State involved regarding the legal rights
19 available to teenage victims of dating violence” be-
20 fore the period.
