Mr. CONNOLLY (for himself and Mr. ROONEY) introduced the following bill;
which was referred to the Committee on Appropriations

A BILL

To amend the Honoring the Families of Fallen Soldiers Act to provide a permanent appropriation of funds for the payment of death gratuities and related benefits for survivors of deceased military service members in event of any future period of lapsed appropriations.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. PERMANENT APPROPRIATION OF FUNDS FOR**
2 **PAYMENT OF DEATH GRATUITIES AND RE-**
3 **LATED BENEFITS FOR SURVIVORS OF DE-**
4 **CEASED MILITARY SERVICE MEMBERS IN**
5 **EVENT OF A PERIOD OF LAPSED APPROPRIA-**
6 **TIONS.**

7 (a) APPROPRIATION.—The Department of Defense
8 Survivor Benefits Continuing Appropriations Resolution,
9 2014 (also known as the Honoring the Families of Fallen
10 Soldiers Act; Public Law 113–44) is amended—

11 (1) in the matter preceding section 101, by in-
12 serting after “fiscal year 2014” the following: “and
13 subsequent fiscal years whenever there is a period of
14 lapsed appropriations”; and

15 (2) in section 101, by adding at the end the fol-
16 lowing new subsection:

17 “(c)(1) During any subsequent period of lapsed ap-
18 propriations during a fiscal year, such amounts as may
19 be necessary, at a rate for operations as provided for the
20 most recent fiscal year for which an Act making appro-
21 priations for the Department of Defense has been enacted
22 and under the authority and conditions provided in such
23 Act, for ‘Operation and Maintenance’ and ‘Military Per-
24 sonnel’ accounts for the purpose of making the payments
25 described in paragraphs (1) through (4) of subsection (a)
26 during the period of lapsed appropriations.

1 “(2) In paragraph (1) and section 103, the term ‘pe-
2 riod of lapsed appropriations’ means any period of time
3 after the start of a fiscal year for which interim (other
4 than pursuant to subsection (a) or paragraph (1)) or full-
5 year appropriations for the accounts referred to in para-
6 graph (1) are not in effect.”.

7 (b) DURATION.—Section 103 of the Department of
8 Defense Survivor Benefits Continuing Appropriations
9 Resolution, 2014 (also known as the Honoring the Fami-
10 lies of Fallen Soldiers Act; Public Law 113–44) is amend-
11 ed to read as follows:

12 “SEC. 103. Appropriations and funds made available
13 and authority granted pursuant to this joint resolution
14 shall be available whenever there is a period of lapsed ap-
15 propriations for the duration of the period of lapsed appro-
16 priations.”.
