## A BILL

To amend title 5, United States Code, to ensure proper manpower on the United States border and to provide for reforms to rates of pay for Border Patrol agents.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Border Patrol Pay Re-  
5 form Act of 2013”.

6 **SEC. 2. BORDER PATROL RATE OF PAY.**

7       (a) PURPOSE.—The purposes of this section are—

7                   (2) to ensure that U.S. Customs and Border  
8                   Protection has the flexibility to cover shift changes  
9                   and retains the right to assign scheduled and un-  
10                  scheduled work for mission requirements and plan-  
11                  ning based on operational need.

12 (b) RATES OF PAY.—Subchapter V of chapter 55 of  
13 title 5, United States Code, is amended by inserting after  
14 section 5549 the following:

## 15 “§ 5550. Border patrol rate of pay

**16**        "(a) DEFINITIONS.—In this section—

17                 “(1) the term ‘available to work’, as used with  
18                 respect to a Border Patrol agent, means that such  
19                 agent is generally and reasonably accessible by U.S.  
20                 Customs and Border Protection to perform unsched-  
21                 uled duty based on the needs of U.S. Customs and  
22                 Border Protection;

23               “(2) the term ‘Border Patrol agent’ means an  
24 individual who is performing functions included  
25 under position classification series 1896 (Border Pa-

1 trol Enforcement) of the Office of Personnel Man-  
2 agement, or any successor thereto, including, in the  
3 case of an individual performing the aforementioned  
4 functions, while such individual is performing cov-  
5 ered border patrol activities;

6 “(3) the term ‘covered border patrol activities’,  
7 as used with respect to a Border Patrol agent,  
8 means—

9 “(A) detecting and preventing illegal entry  
10 and smuggling of aliens, commercial goods, nar-  
11 cotics, weapons, or contraband into the United  
12 States;

13 “(B) arresting individuals suspected of  
14 conduct described in subparagraph (A);

15 “(C) attending training authorized by U.S.  
16 Customs and Border Protection;

17 “(D) being on approved annual, sick, or  
18 administrative leave;

19 “(E) being on ordered travel status;

20 “(F) being on official time, within the  
21 meaning of section 7131;

22 “(G) being on excused absence with pay  
23 for relocation purposes;

24 “(H) being on light duty due to injury or  
25 disability;

1                 “(I) performing administrative duties or  
2 mission critical work assignments while main-  
3 taining law enforcement authority;

4                 “(J) caring for the canine assigned to the  
5 Border Patrol agent, which may not exceed 1  
6 hour per day; or

7                 “(K) engaging in an activity similar to an  
8 activity described in any of the preceding sub-  
9 paragraphs while temporarily away from the  
10 regular duty assignment of the Border Patrol  
11 agent;

12                 “(4) the term ‘level 1 border patrol rate of pay’,  
13 as used with respect to a Border Patrol agent,  
14 means the rate equal to 1.25 times the hourly rate  
15 of basic pay otherwise applicable to such agent;

16                 “(5) the term ‘level 2 border patrol rate of pay’,  
17 as used with respect to a Border Patrol agent,  
18 means the rate equal to 1.125 times the hourly rate  
19 of basic pay otherwise applicable to such agent; and

20                 “(6) the term ‘work period’ means a 14-day bi-  
21 weekly pay period.

22                 “(b) RECEIPT OF BORDER PATROL RATE OF PAY.—

23                 “(1) VOLUNTARY ELECTION.—

24                 “(A) IN GENERAL.—Not later than 30  
25 days before the first day of each year beginning

1           after the date of enactment of this section, a  
2           Border Patrol agent shall make an election as  
3           to whether such agent shall, for such year—

4                 “(i) be assigned to the level 1 border  
5                 patrol rate of pay;

6                 “(ii) be assigned to the level 2 border  
7                 patrol rate of pay; or

8                 “(iii) decline both the level 1 and the  
9                 level 2 border patrol rates of pay.

10           “(B) PROCEDURES.—The Director of the  
11           Office of Personnel Management shall establish  
12           procedures for an election under subparagraph  
13           (A).

14           “(C) INFORMATION REGARDING ELEC-  
15           TION.—Not later than 60 days before the first  
16           day of each year beginning after the date of the  
17           enactment of this section, U.S. Customs and  
18           Border Protection shall provide each Border  
19           Patrol agent with information regarding each  
20           type of election available under subparagraph  
21           (A) and how to make such an election.

22           “(D) FAILURE TO ELECT.—A Border Pa-  
23           trol agent who fails to make a timely election  
24           under subparagraph (A) shall be deemed to  
25           have made an election under clause (i) thereof.

1                 “(E) SENSE OF CONGRESS.—It is the  
2 sense of Congress that U.S. Customs and Bor-  
3 der Protection should take such action as is  
4 necessary to ensure that not more than 10 per-  
5 cent of the Border Patrol agents stationed at a  
6 location decline to be assigned to the level 1  
7 border patrol rate of pay or the level 2 border  
8 patrol rate of pay.

9                 “(2) LEVEL 1 BORDER PATROL RATE OF PAY.—  
10 For a Border Patrol agent who has in effect an elec-  
11 tion under paragraph (1)(A)(i)—

12                 “(A) the Border Patrol agent shall be  
13 scheduled to work for 5 days per week—

14                 “(i) 8 hours of regular time per day;  
15 and

16                 “(ii) 2 additional hours of scheduled  
17 overtime on each day such agent is sched-  
18 uled to work under clause (i);

19                 “(B) for the hours of regular time work  
20 described in subparagraph (A)(i), the Border  
21 Patrol agent shall receive pay at the level 1 bor-  
22 der patrol rate of pay;

23                 “(C) for the hours of regularly scheduled  
24 overtime work described in subparagraph

1                         (A)(ii), the Border Patrol agent shall not re-  
2                         ceive—

3                                 “(i) additional compensation under  
4                         this section or any other provision of law;

5                                 or

6                                 “(ii) compensatory time off;

7                         “(D) any hours during which the Border  
8                         Patrol agent is available to work during a work  
9                         period shall be included in the hours of regular  
10                         time or regularly scheduled overtime scheduled  
11                         under subparagraph (A);

12                         “(E) the Border Patrol agent shall receive  
13                         compensatory time off or pay at the overtime  
14                         hourly rate of pay for hours of work in excess  
15                         of 100 hours during a work period, as deter-  
16                         mined in accordance with section 5542(a)(7);  
17                         and

18                         “(F) the Border Patrol agent shall be  
19                         charged leave in increments of 8 hours for 1  
20                         shift of leave, regardless of the length of the  
21                         shift.

22                         “(3) LEVEL 2 BORDER PATROL RATE OF PAY.—  
23                         For a Border Patrol agent who has in effect an elec-  
24                         tion under paragraph (1)(A)(ii)—

1                 “(A) the Border Patrol agent shall be  
2                 scheduled to work for 5 days per week—

3                         “(i) 8 hours of regular time per day;  
4                         and

5                         “(ii) 1 additional hour of scheduled  
6                 overtime during on each day such agent is  
7                 scheduled to work under clause (i);

8                 “(B) for the hours of regular time work  
9                 described in subparagraph (A)(i), the Border  
10                 Patrol agent shall receive pay at the level 2 bor-  
11                 der patrol rate of pay;

12                 “(C) for the hours of regularly scheduled  
13                 overtime work described in subparagraph  
14                 (A)(ii), the Border Patrol agent shall not re-  
15                 ceive—

16                         “(i) additional compensation under  
17                 this section or any other provision of law;  
18                         or

19                         “(ii) compensatory time off;

20                 “(D) any hours during which the Border  
21                 Patrol agent is available to work during a work  
22                 period shall be included in the hours of regular  
23                 time or regularly scheduled overtime scheduled  
24                 under subparagraph (A);

1                 “(E) the Border Patrol agent shall receive  
2 compensatory time off or pay at the overtime  
3 hourly rate of pay for hours of work in excess  
4 of 90 hours during a work period, as deter-  
5 mined in accordance with section 5542(a)(7);  
6 and

7                 “(F) the Border Patrol agent shall be  
8 charged leave in increments of 8 hours for 1  
9 shift of leave, regardless of the length of the  
10 shift.

11                 “(4) BASIC BORDER PATROL RATE OF PAY.—  
12 For a Border Patrol agent who has in effect an elec-  
13 tion under paragraph (1)(A)(iii)—

14                 “(A) the Border Patrol agent shall be  
15 scheduled to work 8 hours of regular time per  
16 day, 5 days per week;

17                 “(B) any hours during which the Border  
18 Patrol agent is available to work during a work  
19 period shall be included in the hours of regular  
20 time scheduled under subparagraph (A); and

21                 “(C) the Border Patrol agent shall receive  
22 compensatory time off or pay at the overtime  
23 hourly rate of pay for hours of work in excess  
24 of 80 hours during a work period, as deter-  
25 mined in accordance with section 5542(a)(7).

1       “(c) ELIGIBILITY FOR OTHER PREMIUM PAY.—A

2 Border Patrol agent—

3           “(1) shall receive premium pay for night work  
4       in accordance with subsections (a) and (b) of section  
5       5545 and Sunday and holiday pay in accordance  
6       with section 5546, without regard to the election of  
7       the Border Patrol agent under subsection (b)(1)(A),  
8       except that section 5546(d) shall not apply and eligi-  
9       bility for pay for, and the rate of pay for, any over-  
10      time work shall be determined in accordance with  
11      this section and section 5542(a)(7); and

12           “(2) shall not be eligible for any other form of  
13      premium pay under this title, except as provided in  
14      section 5542(a)(7).

15           “(d) TREATMENT AS BASIC PAY.—Any pay received  
16      at the level 1 border patrol rate of pay or the level 2 border  
17      patrol rate of pay or pay described in subsection (b)(3)(B)  
18      shall be treated as part of basic pay for—

19           “(1) purposes of sections 5595(c), 8114(e),  
20      8331(3), and 8704(c);

21           “(2) any other purpose that the Office of Per-  
22      sonnel Management may by regulation prescribe;  
23      and

24           “(3) any other purpose expressly provided for  
25      by law.

1        “(e) AUTHORITY TO REQUIRE OVERTIME WORK.—

2 Nothing in this section shall be construed to limit the au-  
3 thority of U.S. Customs and Border Protection to require  
4 a Border Patrol agent to perform hours of overtime work  
5 in accordance with the needs of U.S. Customs and Border  
6 Protection, including if needed in the event of a local or  
7 national emergency.”.

8        (c) OVERTIME WORK.—Section 5542(a) of title 5,  
9 United States Code, is amended by adding at the end the  
10 following:

11        “(7)(A) In this paragraph, the term ‘Border Patrol  
12 agent’ has the meaning given such term in section 5550.

13        “(B) Notwithstanding the matter preceding para-  
14 graph (1) or paragraphs (1) and (2), for a Border Patrol  
15 agent who has in effect an election to be assigned to the  
16 level 1 border patrol rate of pay under section  
17 5550(b)(1)(A)(i)—

18                “(i) except as provided in subparagraph (E),  
19                hours of work in excess of 100 hours during a 14-  
20                day biweekly pay period shall be overtime work; and

21                “(ii) the Border Patrol agent—

22                        “(I) shall receive pay at the overtime hour-  
23                        ly rate of pay (as determined in accordance  
24                        with paragraphs (1) and (2)) for hours of over-

1 time work that are officially ordered or ap-  
2 proved in advance of the work assignment; and

3 “(II) shall receive compensatory time off  
4 for any hours of overtime work that are not  
5 hours of overtime work described in subclause  
6 (I).

7 “(C) Notwithstanding the matter preceding para-  
8 graph (1) or paragraphs (1) and (2), for a Border Patrol  
9 agent who has in effect an election to be eligible for the  
10 level 2 border patrol rate of pay under section  
11 5550(b)(1)(A)(ii)—

12 “(i) except as provided in subparagraph (E),  
13 hours of work in excess of 90 hours during a 14-day  
14 biweekly pay period shall be overtime work; and

15 “(ii) the Border Patrol agent—

16 “(I) shall receive pay at the overtime hourly  
17 rate of pay (as determined in accordance  
18 with paragraphs (1) and (2)) for hours of over-  
19 time work that are officially ordered or ap-  
20 proved in advance of the work assignment; and

21 “(II) shall receive compensatory time off  
22 for any hours of overtime work that are not  
23 hours of overtime work described in subclause  
24 (I).

1       “(D) Notwithstanding the matter preceding para-  
2 graph (1) or paragraphs (1) and (2), for a Border Patrol  
3 agent who has in effect an election under section  
4 5550(b)(1)(A)(iii)—

5           “(i) except as provided in subparagraph (E),  
6 hours of work in excess of 80 hours during a 14-day  
7 biweekly pay period shall be overtime work; and

8           “(ii) the Border Patrol agent—

9           “(I) shall receive pay at the overtime hour-  
10 ly rate of pay (as determined in accordance  
11 with paragraphs (1) and (2)) for hours of over-  
12 time work that are officially ordered or ap-  
13 proved in advance of the work assignment; and

14           “(II) shall receive compensatory time off  
15 for any hours of overtime work that are not  
16 hours of overtime work described in subclause  
17 (I).

18       “(E)(i) Except as provided in clause (ii), during a  
19 14-day biweekly pay period, a Border Patrol agent shall  
20 not perform and may not receive compensatory time off  
21 for more than 8 hours of overtime work.

22       “(ii) U.S. Customs and Border Protection may, as  
23 it determines appropriate, waive the limitation under  
24 clause (i) for hours of overtime work, but such waiver  
25 must be approved in advance of any work being performed

1 that would be subject to compensatory time under sub-  
2 section (B)(ii)(II), (C)(ii)(II), or (D)(ii)(II).

3       “(F) A Border Patrol agent—

4           “(i) may not earn more than 240 hours of com-  
5 pensatory time off during a year; and

6           “(ii) shall use any hours of compensatory time  
7 off not later than 1 year after the date on which the  
8 compensatory time off is accrued.”.

9       (d) TECHNICAL AND CONFORMING AMENDMENTS.—

10           (1) Section 13(a) of the Fair Labor Standards  
11 Act of 1938 (29 U.S.C. 213(a)) is amended—

12               (A) in paragraph (16), by striking “or”  
13 after the semicolon;

14               (B) in paragraph (17), by striking the pe-  
15 riod at the end and inserting “; or”; and

16               (C) by adding at the end the following:

17               “(18) any employee who is a Border Patrol  
18 agent, as defined in section 5550(a) of title 5,  
19 United States Code.”.

20           (2) The table of sections for chapter 55 of title  
21 5, United States Code, is amended by inserting after  
22 the item relating to section 5549 the following:

“5550. Border patrol rate of pay.”.
