## A BILL

To establish a research program under the Congressionally Directed Medical Research Program of the Department of Defense to discover a cure for HIV/AIDS.

1       *Be it enacted by the Senate and House of Representa-  
2       tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Cure for AIDS Act  
5       of 2013”.

1     **SEC. 2. SENSE OF CONGRESS; FINDINGS.**

2         (a) SENSE OF CONGRESS.—It is the sense of Con-  
3 gress that—

4             (1) finding a cure is essential to ending the  
5 AIDS epidemic in the United States and globally;

6             (2) AIDS treatment has saved millions of lives  
7 and also makes it much less likely that HIV infec-  
8 tion will be passed to a partner;

9             (3) access to AIDS treatment in the United  
10 States and globally needs to continue to be expanded  
11 but AIDS treatment is not a cure and not the ulti-  
12 mate solution for the tens of millions of people living  
13 with HIV/AIDS;

14             (4) the National Institutes of Health is the  
15 leading health research organization in the world  
16 and has dedicated millions of dollars to AIDS cure  
17 research;

18             (5) to accelerate AIDS cure research and prod-  
19 uct development, it is becoming increasingly impor-  
20 tant to invest in areas that can complement the es-  
21 sential role of the National Institutes of Health; and

22             (6) a cure will save hundreds of millions of dol-  
23 lars in spending and have a powerful positive eco-  
24 nomic impact globally.

25         (b) FINDINGS.—Congress finds the following:

1                   (1) It is estimated that in 2012 roughly  
2       35,300,000 people were living with HIV/AIDS  
3       worldwide.

4                   (2) In the United States, 1,200,000 Americans  
5       are estimated to be infected with the virus.

6                   (3) Every 9.5 minutes, a citizen of the United  
7       States becomes infected with HIV. Roughly  
8       2,700,000 individuals, including 390,000 children,  
9       became newly infected with HIV in 2010 alone.

10                  (4) In fiscal year 2012, the Federal Govern-  
11       ment spent \$27,700,000,000 on HIV/AIDS, the  
12       largest component being services and treatment for  
13       people living with HIV/AIDS in the United States at  
14       a cost of \$15,600,000,000. The average lifetime cost  
15       of HIV treatment is estimated to be \$367,134 per  
16       person.

17                  (5) In the last two years, discoveries have led  
18       to growing optimism in the scientific community  
19       that a cure for AIDS can be found. The eradication  
20       of HIV from the body of one individual in Germany  
21       has led many scientific leaders to believe that curing  
22       AIDS is now possible. Leading researchers believe  
23       we are now at the cutting edge of scientific discovery  
24       for an AIDS cure with a range of novel approaches  
25       being explored, including stem cells, gene therapy,

medications, and immune response modifications, such as therapeutic vaccines.

**3 SEC. 3. ESTABLISHMENT OF HIV/AIDS CONGRESSIONALLY  
4 DIRECTED MEDICAL RESEARCH PROGRAM.**

5 (a) ESTABLISHMENT OF RESEARCH PROGRAM.—

6                         (1) IN GENERAL.—The Secretary of Defense,  
7                         acting through the Congressionally Directed Medical  
8                         Research Program, shall establish and support an  
9                         accelerated research program dedicated to the dis-  
0                         covery of a cure for HIV/AIDS.

18 (C) any head of a Federal agency that the  
19 Secretary determines appropriate.

20           (b) SCOPE.—To provide the basis for developing a  
21 cure for HIV/AIDS, the Secretary shall ensure that re-  
22 search conducted under subsection (a)(1) is highly tar-  
23 geted to address the following scientific questions and pri-  
24 orities:

1                             (1) How HIV persists despite antiretroviral  
2                             therapy.

3                             (2) Where HIV persists beyond the reach of  
4                             antiretroviral therapy.

5                             (3) Whether ongoing attempts of the immune  
6                             system to clear the infection actually hinders the  
7                             ability of the medical community to cure infected in-  
8                             dividuals.

9                             (4) Why the immune system reduces but does  
10                            not eliminate levels of the virus.

11                            (5) How to measure ultra-low levels of the virus  
12                            in the body of an infected individual.

13                            (6) Identifying and testing interventions, such  
14                            as drugs, that may eliminate the virus from infected  
15                            individuals.

16                            (7) Identifying and testing interventions, such  
17                            as vaccines, that may help an infected individual  
18                            permanently control the virus without antiretroviral  
19                            therapy.

20                            (c) ASSISTANCE BY NONPROFIT ENTITIES.—

21                            (1) COORDINATION.—In carrying out the re-  
22                            search program established under subsection (a)(1),  
23                            the Secretary shall coordinate with at least one eligi-  
24                            ble nonprofit entity—

1                             (A) whose primary mission is ending the  
2                             AIDS epidemic through innovative research;  
3                             and

4                             (B) that has experience carrying out pro-  
5                             grams dedicated to AIDS cure research.

6                             (2) RESPONSIBILITIES.—The Secretary shall  
7                             ensure that the responsibilities of a nonprofit entity  
8                             selected under paragraph (1) include partnering with  
9                             the Secretary to establish research priorities for  
10                            peer-reviewed funded research pursuant to sub-  
11                            section (b).

12                            (d) ANNUAL REPORTS.—In each annual report on  
13                             the Congressionally Directed Medical Research Program  
14                             that the Secretary submits to Congress, the Secretary  
15                             shall include information on the progress of the research  
16                             program established under subsection (a)(1).

17                            (e) AUTHORIZATION OF APPROPRIATIONS.—There is  
18                             authorized to be appropriated to carry out this section  
19                             \$20,000,000 for each of fiscal years 2014 through 2018.
