## A BILL

To require the Comptroller General to produce annual reports on programs under the Foreign Intelligence Surveillance Act of 1978.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Security  
5 Agency Accountability Act”.

1 **SEC. 2. ANNUAL REPORT BY THE COMPTROLLER GENERAL**  
2 **ON PROGRAMS UNDER THE FOREIGN INTEL-**  
3 **LIGENCE SURVEILLANCE ACT OF 1978.**

4 (a) REPORT.—Title VI of the Foreign Intelligence  
5 Surveillance Act of 1978 (50 U.S.C. 1871 et seq.) is  
6 amended by adding at the end the following new section:

7 **“SEC. 602. ANNUAL REPORT BY THE COMPTROLLER GEN-**  
8 **ERAL.**

9 “(a) REPORT.—The Comptroller General of the  
10 United States shall annually submit to the Permanent Se-  
11 lect Committee on Intelligence and the Committee on the  
12 Judiciary of the House of Representatives and the Select  
13 Committee on Intelligence and the Committee on the Judi-  
14 ciary of the Senate a report on the effectiveness of the  
15 programs and activities carried out under this Act.

16 “(b) CONTENTS.—Each report under subsection (a)  
17 shall include—

18 “(1) an analysis of the restrictions placed on  
19 access to information obtained under this Act;

20 “(2) the number of incidents of non-compliance  
21 with this Act or any rule, regulation, policy, or pro-  
22 cedure to carry out this Act;

23 “(3) a description of actions taken in response  
24 to incidents of non-compliance described in para-  
25 graph (2);

1           “(4) a description of the minimization proce-  
2           dures used to carry out each provision of this Act;

3           “(5) a description of how such minimization  
4           procedures are verified to be in use and effective;

5           “(6) the number of applications made under  
6           each appropriate provision of this Act, the number  
7           of such applications approved by a court, and the  
8           number of times such applications resulted in an  
9           oral argument before the court;

10           “(7) the number of times employees of or con-  
11           tractors to the National Security Agency search in-  
12           formation acquired under this Act; and

13           “(8) any other information the Comptroller  
14           General considers appropriate.

15           “(c) PUBLIC DISCLOSURE.—At the time of submis-  
16           sion of each report required under subsection (a), the  
17           Comptroller General shall make publicly available an un-  
18           classified summary of such report.”.

19           (b) TABLE OF CONTENTS AMENDMENT.—The table  
20           of contents in the first section of the Foreign Intelligence  
21           Surveillance Act of 1978 is amended by inserting after the  
22           item relating to section 601 the following new item:

“Sec. 602. Annual report by the Comptroller General.”.
