A BILL

To amend the Small Business Act to raise the prime and subcontract goals, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Greater Opportunities
5 for Small Business Act of 2014”.

6 **SEC. 2. SMALL BUSINESS PRIME AND SUBCONTRACT PAR-**
7 **TICIPATION GOALS RAISED.**

8 (a) GOALS IN SUBCONTRACTING PLANS.—Section
9 8(d)(6)(A) of the Small Business Act (15 U.S.C.
10 637(d)(6)(A)) is amended by inserting after “percentage
11 goals” the following: “of not less than 40 percent”.

12 (b) PRIME CONTRACTING GOALS.—Section
13 15(g)(1)(A)(i) of the Small Business Act (15 U.S.C.
14 644(g)(1)(A)(i)) is amended by striking “23 percent” and
15 inserting “25 percent”.

16 (c) DELAYED EFFECTIVE DATE.—The amendment
17 made by subsection (a) of this section shall take effect
18 only beginning on the date on which the Administrator
19 of the Small Business Administration has promulgated
20 any regulations necessary, and the Federal Acquisition
21 Regulation has been revised, to implement section 1614
22 of the National Defense Authorization Act for Fiscal Year
23 2014 and the amendments made by such section.

1 **SEC. 3. REPEAL OF CERTAIN PROVISION PERTAINING TO**
2 **ACCOUNTING OF SUBCONTRACTORS.**

3 Section 15(g) of the Small Business Act (15 U.S.C.
4 644(g)) is amended by striking paragraph (3).
