# A BILL

To direct the Administrator of the Small Business Administration to develop and implement a plan to improve the quality of data reported on bundled and consolidated contracts, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*  
3   **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Contracting Data and*  
5   *Bundling Accountability Act of 2014”.*

6   **SEC. 2. PLAN FOR IMPROVING DATA ON BUNDLED AND**  
7                   **CONSOLIDATED CONTRACTS.**

8       *Section 15 of the Small Business Act (15 U.S.C. 644)*  
9   *is amended by adding at the end the following new sub-*  
10   *section:*

11      “(s) DATA QUALITY IMPROVEMENT PLAN.—

12       “(1) IN GENERAL.—Not later than the first day  
13    of fiscal year 2016, the Administrator of the Small  
14   Business Administration, in consultation with the  
15   Small Business Procurement Advisory Council, the  
16   Administrator of the Office of Federal Procurement  
17   Policy, and the Administrator of the General Services  
18   Administration shall develop a plan to improve the  
19   quality of data reported on bundled and consolidated  
20   contracts in the Federal procurement data system.

21       “(2) PLAN REQUIREMENTS.—The plan shall—

22           “(A) describe the roles and responsibilities  
23    of the Administrator of the Small Business Ad-  
24   ministration, the Directors of the Offices of  
25   Small and Disadvantaged Business Utilization,

1           *the Small Business Procurement Advisory Coun-*  
2           *cil, the Administrator of the Office of Federal*  
3           *Procurement Policy, the Administrator of the*  
4           *General Services Administration, the senior pro-*  
5           *curement executives, and Chief Acquisition Offi-*  
6           *cers in implementing the plan described in para-*  
7           *graph (1) and contributing to the annual report*  
8           *required by subsection (p)(4);*

9           “(B) make necessary changes to policies and  
10          procedures on proper identification and mitigation  
11          of contract bundling and consolidation, and  
12          to training procedures of relevant personnel on  
13          proper identification and mitigation of contract  
14          bundling and consolidation;

15          “(C) establish consequences for failure to  
16          properly identify contracts as bundled or consoli-  
17          dated;

18          “(D) establish requirements for periodic and  
19          statistically valid data verification and valida-  
20          tion; and

21          “(E) assign clear data verification respon-  
22          sibilities.

23          “(3) COMMITTEE BRIEFING.—Once finalized and  
24          by not later than 90 days prior to implementation,  
25          the plan described in this subsection shall be presented

1       *to the Committee on Small Business of the House of  
2       Representatives and the Committee on Small Business  
3       and Entrepreneurship of the Senate.*

4       “*(4) IMPLEMENTATION.—Not later than the first  
5       day of fiscal year 2017, the Administrator of the  
6       Small Business Administration shall implement the  
7       plan described in this subsection.*

8       “*(5) CERTIFICATION.—The Administrator shall  
9       annually provide to the Committee on Small Business  
10      of the House of Representatives and the Committee on  
11      Small Business and Entrepreneurship of the Senate  
12      certification of the accuracy and completeness of data  
13      reported on bundled and consolidated contracts.*

14       “*(6) GAO STUDY AND REPORT.—*

15           “*(A) STUDY.—Not later than the first day  
16          of fiscal year 2018, the Comptroller General of  
17          the United States shall initiate a study on the  
18          effectiveness of the plan described in this sub-  
19          section that shall assess whether contracts were  
20          accurately labeled as bundled or consolidated.*

21           “*(B) CONTRACTS EVALUATED.—For the  
22          purposes of conducting the study described in  
23          subparagraph (A), the Comptroller General of  
24          the United States—*

1                   “(i) shall evaluate, for work in each of  
2                   sectors 23, 33, 54, and 56 (as defined by the  
3                   North American Industry Classification  
4                   System), not fewer than 100 contracts in  
5                   each sector;

6                   “(ii) shall evaluate only those con-  
7                   tracts—

8                   “(I) awarded by an agency listed  
9                   in section 901(b) of title 31, United  
10                  States Code; and

11                  “(II) that have a Base and Exer-  
12                  cised Options Value, an Action Obliga-  
13                  tion, or a Base and All Options Value;  
14                  and

15                  “(iii) shall not evaluate contracts that  
16                  have used any set aside authority.

17                  “(C) REPORT.—Not later than 12 months  
18                  after initiating the study required by subpara-  
19                  graph (A), the Comptroller General of the United  
20                  States shall report to the Committee on Small  
21                  Business of the House of Representatives and the  
22                  Committee on Small Business and Entrepreneur-  
23                  ship of the Senate on the results from such study  
24                  and, if warranted, any recommendations on how

1           *to improve the quality of data reported on bun-*  
2           *dled and consolidated contracts.*

3           “(7) *DEFINITIONS.*—*In this subsection the fol-*  
4           *lowing definitions shall apply:*

5           “(A) *CHIEF ACQUISITION OFFICER; SENIOR*  
6           *PROCUREMENT EXECUTIVE.*—*The terms ‘Chief*  
7           *Acquisition Officer’ and ‘senior procurement ex-*  
8           *ecutive’ have the meanings given such terms in*  
9           *section 44 of this Act.*

10          “(B) *FEDERAL PROCUREMENT DATA SYS-*  
11          *TEM DEFINITIONS.*—*The terms ‘Base and Exer-*  
12          *cised Options Value’, ‘Action Obligation’, ‘Base*  
13          *and All Options Value’, and ‘set aside authority’*  
14          *have the meanings given such terms by the Ad-*  
15          *ministrator for Federal Procurement Policy in*  
16          *the Federal procurement data system on October*  
17          *1, 2013, or subsequent equivalent terms.”.*
