To establish a grant program for nebulizers in elementary and secondary schools.

IN THE HOUSE OF REPRESENTATIVES

Ms. JACKSON LEE (for herself, Mr. VARGAS, and Ms. CLARKE of New York) introduced the following bill; which was referred to the Committee on Education and the Workforce, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To establish a grant program for nebulizers in elementary and secondary schools.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Breath of Fresh Air
5 Act”.

6 **SEC. 2. FINDINGS.**

7 The Congress finds as follows:

1 (1) 25,000,000 people, including 7,000,000
2 children, have asthma.

3 (2) Almost 13,000,000 people report having an
4 asthma attack in the past year and asthma accounts
5 for nearly 2,000,000 emergency department visits
6 each year.

7 (3) Every day in the United States—

8 (A) 30,000 people have an asthma attack;
9 and

10 (B) 11 people die from asthma.

11 (4) Nearly 5,000,000 asthma sufferers are
12 under 18 years of age, and 1 out of every 10 school-
13 aged children has asthma.

14 (5) Minorities are adversely affected by asthma,
15 as—

16 (A) African-Americans are 3 times more
17 likely to die from asthma; and

18 (B) Hispanics may have an elevated risk
19 for exposure to air pollution since a dispropor-
20 tionate number live in areas failing to meet one
21 or more national standards for air pollutants.

22 (It is estimated that 80 percent of Hispanics
23 live in areas that failed to meet one United
24 States Environmental Protection Agency air

1 quality standard, compared to 65 percent of Af-
2 rican-Americans and 57 percent of Whites.)

3 **SEC. 3. GRANT PROGRAM FOR NEBULIZERS.**

4 (a) PROGRAM REQUIRED.—The Secretary of Edu-
5 cation shall carry out a program under which the Sec-
6 retary makes grants to local educational agencies, to be
7 used by the local educational agencies for one or both of
8 the following:

9 (1) To purchase nebulizers for use in elemen-
10 tary and secondary schools served by the local edu-
11 cational agency.

12 (2) To provide training to enable elementary
13 and secondary schools served by the local edu-
14 cational agency to meet the requirements of sub-
15 section (d)(1), but only if nebulizers are already in
16 use at such schools or are acquired through this pro-
17 gram.

18 (b) ELIGIBILITY.—

19 (1) LOCAL EDUCATIONAL AGENCIES.—To be el-
20 igible to receive a grant under this section, a local
21 educational agency shall submit an application to
22 the Secretary at such time, in such form, and con-
23 taining such information as the Secretary may re-
24 quire.

1 (2) ELEMENTARY AND SECONDARY SCHOOLS.—

2 To be eligible to receive a nebulizer through a grant
3 under this section, a school may be any public or
4 private school served by the local educational agency,
5 except that an Internet- or computer-based commu-
6 nity school is not eligible.

7 (c) MATCHING FUNDS REQUIRED.—

8 (1) IN GENERAL.—To be eligible to receive a
9 grant under this section, the local educational agen-
10 cy must provide matching funds from non-Federal
11 sources equal to not less than 25 percent of the
12 amount of the grant.

13 (2) WAIVER.—The Secretary shall waive the re-
14 quirement of paragraph (1) for a local educational
15 agency if the number of children counted under sec-
16 tion 1124(c)(1)(A) of the Elementary and Secondary
17 Education Act of 1965 (20 U.S.C. 6333(c)(1)(A)) is
18 20 percent or more of the total number of children
19 aged 5 to 17, inclusive, served by the local edu-
20 cational agency.

21 (d) TRAINING AND COORDINATION REQUIRED.—A
22 local educational agency that receives a grant under this
23 section shall demonstrate that, for each elementary and
24 secondary school at which the nebulizers are to be used—

1 (1) there is a full-time certified school nurse on
2 staff;

3 (2) the school has the trained personnel and
4 other resources necessary to use the nebulizers;

5 (3) local paramedics and other emergency serv-
6 ices personnel are notified where on school grounds
7 the nebulizers are to be located;

8 (4) the nebulizer will be integrated into the
9 school's emergency response plan or procedures; and

10 (5) the school has procedures in place to ensure
11 that parents are notified of the availability of the
12 nebulizers, how to provide their child's prescription
13 asthma medication to the school, and how to author-
14 ize use of a nebulizer to assist their child when
15 medically appropriate.

16 (e) PRIORITY.—In making grants under this section,
17 the Secretary shall give priority to local educational agen-
18 cies—

19 (1) having jurisdiction over a geographic area
20 with respect to which the Director of the Centers for
21 Disease Control and Prevention has determined that
22 the prevalence of asthma is at least 10 percent high-
23 er than the national average;

1 (2) that do not already have at least one
2 nebulizer in each school served by the local edu-
3 cational agency;

4 (3) serve schools at which a significant number
5 of students, staff, and visitors are present on school
6 grounds during a typical day; and

7 (4) that have not received funds under the
8 Rural Access to Emergency Devices Act (42 U.S.C.
9 254c note).

10 (f) ESEA DEFINITIONS.—The terms used in this sec-
11 tion shall have the meanings given to such terms in section
12 9101 of the Elementary and Secondary Education Act of
13 1965 (20 U.S.C. 7801).

14 (g) AUTHORIZATION OF APPROPRIATIONS.—There
15 are authorized to be appropriated to carry out this section
16 such sums as may be necessary for each of fiscal years
17 2014 through 2019.

18 **SEC. 4. CONSTRUCTION.**

19 Nothing in this Act shall be construed—

20 (1) to create liability for use of a nebulizer or
21 affect liability for such use that exists under other
22 law; or

23 (2) to supersede a State law regulating nursing.
