## A BILL

To amend the Patient Protection and Affordable Care Act to eliminate Exchange cost-sharing subsidies, to amend title XVIII of the Social Security Act to create a Medicare Advantage Improvement Fund, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Seniors’ Fairness Act  
5       of 2014”.

## 1 SEC. 2. CREATING MEDICARE ADVANTAGE IMPROVEMENT

## 2 FUND.

3 Section 1859 of the Social Security Act (42 U.S.C.

4 1395w–28) is amended by adding at the end the following

5 new subsection:

## 6 “(h) MEDICARE ADVANTAGE IMPROVEMENT

## 7 FUND.—

8 “(1) ESTABLISHMENT.—The Secretary shall es-  
9 tablish under this title a Medicare Advantage Im-  
10 provement Fund (in this subsection referred to as  
11 the ‘Fund’) which shall be available to make im-  
12 provements under the Medicare Advantage program  
13 under this part, including by—14 “(A) preventing cost-sharing increases and  
15 the loss of benefits to individuals enrolled in  
16 MA plans; and17 “(B) ensuring individuals enrolled in MA  
18 plans can access a high-quality network of pro-  
19 viders.

## 20 “(2) FUNDING.—

21 “(A) IN GENERAL.—There shall be avail-  
22 able to the Fund, for expenditures from the  
23 Fund during the period of fiscal years 2014  
24 through 2023, \$150,000,000,000.

1                 “(B) FUNDING LIMITATION.—Amounts in  
2                 the Fund shall be available to the Secretary  
3                 only pursuant to an appropriations Act.”.

4 **SEC. 3. ELIMINATING EXCHANGE COST-SHARING SUB-**  
5 **SIDIES UNDER PPACA.**

6                 (a) IN GENERAL.—Section 1402 of the Patient Pro-  
7 tection and Affordable Care Act (42 U.S.C. 18071) is  
8 amended by adding at the end the following new sub-  
9 section:

10                 “(g) TERMINATION OF REDUCED COST-SHARING BE-  
11 GINNING IN PLAN YEAR 2015.—The provisions of this  
12 section shall not apply with respect to plan years after  
13 plan year 2014.”.

14                 (b) CONFORMING AMENDMENTS.—

15                 (1) FAIR LABOR STANDARDS ACT OF 1938.—  
16                 Section 18B(a)(2) of the Fair Labor Standards Act  
17                 of 1938 (29 U.S.C. 218b(a)(2)) is amended—

18                         (A) by striking “1986 and” and inserting  
19                         “1986 and, in the case of plan year 2014,”;  
20                         and

21                         (B) by inserting a comma after “Care  
22                         Act”.

23                 (2) MEDICAID.—Section 1943(b)(1)(C) of the  
24                 Social Security Act (42 U.S.C. 1396w-3(b)(1)(C)) is  
25                 amended by inserting “(for plan years in which the

1       provisions of such section apply)” after “section  
2       1402 of the Patient Protection and Affordable Care  
3       Act’.
