Mr. MAFFEI introduced the following bill; which was referred to the
Committee on the Judiciary

A BILL

For the relief of Zenon Kolenda and Orysy Bilyanska
Kolenda.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR ZENON**
4 **KOLENDA AND ORYSYA BILYANSKA**
5 **KOLENDA.**

6 (a) IN GENERAL.—Notwithstanding subsections (a)
7 and (b) of section 201 of the Immigration and Nationality
8 Act, Zenon Kolenda and Orysy Bilyanska Kolenda shall
9 each be eligible for issuance of an immigrant visa or for
10 adjustment of status to that of an alien lawfully admitted
11 for permanent residence upon filing an application for

1 issuance of an immigrant visa under section 204 of such
2 Act or for adjustment of status to lawful permanent resi-
3 dent.

4 (b) ADJUSTMENT OF STATUS.—If Zenon Kolenda or
5 Orysya Bilyanska Kolenda enters the United States before
6 the filing deadline specified in subsection (c), he or she
7 shall be considered to have entered and remained lawfully
8 and shall, if otherwise eligible, be eligible for adjustment
9 of status under section 245 of the Immigration and Na-
10 tionality Act as of the date of the enactment of this Act.

11 (c) DEADLINE FOR APPLICATION AND PAYMENT OF
12 FEES.—Subsections (a) and (b) shall apply only if the ap-
13 plication for issuance of an immigrant visa or the applica-
14 tion for adjustment of status is filed with appropriate fees
15 within 2 years after the date of the enactment of this Act.

16 (d) REDUCTION OF IMMIGRANT VISA NUMBER.—
17 Upon the granting of an immigrant visa or permanent resi-
18 dence to Zenon Kolenda and Orysya Bilyanska Kolenda,
19 the Secretary of State shall instruct the proper officer to
20 reduce by 2, during the current or next following fiscal
21 year, the total number of immigrant visas that are made
22 available to natives of the country of the aliens' birth
23 under section 203(a) of the Immigration and Nationality
24 Act or, if applicable, the total number of immigrant visas

1 that are made available to natives of the country of the
2 aliens' birth under section 202(e) of such Act.

3 (e) DENIAL OF PREFERENTIAL IMMIGRATION
4 TREATMENT FOR CERTAIN RELATIVES.—The natural
5 parents, brothers, and sisters of Zenon Kolenda and
6 Orysy Bilyanska Kolenda shall not, by virtue of such re-
7 lationship, be accorded any right, privilege, or status
8 under the Immigration and Nationality Act.
