## A BILL

To grant a Federal charter to the National American Indian  
Veterans, Incorporated.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. RECOGNITION AS CORPORATION AND GRANT**  
4                   **OF FEDERAL CHARTER FOR NATIONAL**  
5                   **AMERICAN INDIAN VETERANS, INCOR-**  
6                   **PORATED.**

7       (a) IN GENERAL.—Part B of subtitle II of title 36,  
8       United States Code, is amended by inserting after chapter  
9       1503 the following new chapter:

1       **“CHAPTER 1504—NATIONAL AMERICAN**  
2       **INDIAN VETERANS, INCORPORATED**

3       **“§ 150401. Organization**

4           “(a) FEDERAL CHARTER.—The National American  
5      Indian Veterans, Incorporated, a nonprofit corporation or-  
6      ganized in the United States (in this chapter referred to  
7      as the ‘corporation’), is a federally chartered corporation.

8           “(b) INDEPENDENT STATUS OF CORPORATION.—The  
9      corporation is not an agency or instrumentality of the  
10     Federal Government.

11       **“§ 150402. Purposes**

12           “The purposes of the corporation are those stated in  
13      its articles of incorporation, constitution, and bylaws, and  
14      include a commitment—

15           “(1) to uphold and defend the Constitution of  
16      the United States while respecting the sovereignty of  
17      the American Indian, Alaska Native, and Native Ha-  
18      waiian Nations;

1               “(2) to unite under one body all American Indian,  
2               Alaska Native, and Native Hawaiian veterans  
3               who served in the Armed Forces of United States;

4               “(3) to be an advocate on behalf of all American  
5               Indian, Alaska Native, and Native Hawaiian  
6               veterans without regard to whether they served during  
7               times of peace, conflict, or war;

8               “(4) to be an advocate for all veterans suffering  
9               from service-connected disabilities;

10               “(5) to promote social welfare (including educational,  
11               economic, social, physical, cultural values,  
12               and traditional healing) in the United States by encouraging  
13               the growth and development, readjustment, self-respect,  
14               self-confidence, contributions, and self-identity of American Indian veterans;

16               “(6) to serve as an advocate for the needs of  
17               American Indian, Alaska Native, and Native Hawaiian  
18               veterans, their families, or survivors in their  
19               dealings with all Federal and State Government  
20               agencies;

21               “(7) to promote, support, and use research, on  
22               a nonpartisan basis, pertaining to the relationship  
23               between the American Indian, Alaska Native, and  
24               Native Hawaiian veterans and American society; and

1               “(8) to provide technical assistance to all re-  
2         gional areas without veterans committees or organi-  
3         zations and programs by—

4               “(A) providing outreach service to those  
5         tribes in need; and

6               “(B) training and educating Tribal Vet-  
7         erans Service Officers for those tribes in need.

8         **“§ 150403. Membership”**

9               “(a) IN GENERAL.—Subject to subsection (b) and  
10      section 150406 of this title, eligibility for membership in  
11      the corporation, and the rights and privileges of members,  
12      shall be as provided in the constitution and bylaws of the  
13      corporation.

14               “(b) LIMITATION.—Eligibility for membership in the  
15      corporation and the rights and privileges of members shall  
16      not be determined by the Federal Government.

17         **“§ 150404. Board of directors”**

18               “Subject to section 150406 of this title, the board  
19      of directors of the corporation, and the responsibilities of  
20      the board, shall be as provided in the constitution and by-  
21      laws of the corporation and in conformity with the laws  
22      under which the corporation is incorporated.

23         **“§ 150405. Officers”**

24               “Subject to section 150406 of this title, the officers  
25      of the corporation, and the election of such officers, shall

1 be as provided in the constitution and bylaws of the cor-  
2 poration and in conformity with the laws of the jurisdic-  
3 tion under which the corporation is incorporated.

4 **“§ 150406. Nondiscrimination”**

5 “In establishing the conditions of membership in the  
6 corporation, and in determining the requirements for serv-  
7 ing on the board of directors or as an officer of the cor-  
8 poration, the corporation may not discriminate on the  
9 basis of race, color, religion, sex, national origin, handicap,  
10 or age.

11 **“§ 150407. Powers”**

12 “The corporation shall have only those powers grant-  
13 ed the corporation through its articles of incorporation  
14 and its constitution and bylaws, which shall conform to  
15 the laws of the jurisdiction under which the corporation  
16 is incorporated.

17 **“§ 150408. Exclusive right to name, seals, emblems,  
18 and badges”**

19 “(a) IN GENERAL.—The corporation shall have the  
20 sole and exclusive right to use the names ‘National Amer-  
21 ian Indian Veterans, Incorporated’ and ‘National Amer-  
22 ian Indian Veterans’, and such seals, emblems, and  
23 badges as the corporation may lawfully adopt.

1        “(b) CONSTRUCTION.—Nothing in this section shall  
2 be construed to interfere or conflict with established or  
3 vested rights.

4 **“§ 150409. Restrictions**

5        “(a) STOCK AND DIVIDENDS.—The corporation shall  
6 have no power to issue any shares of stock nor to declare  
7 or pay any dividends.

8        “(b) DISTRIBUTION OF INCOME OR ASSETS.—

9            “(1) No part of the income or assets of the cor-  
10 poration shall inure to any person who is a member,  
11 officer, or director of the corporation or be distrib-  
12 uted to any such person during the life of the char-  
13 ter granted by this chapter.

14            “(2) Nothing in this subsection shall be con-  
15 strued to prevent the payment of reasonable com-  
16 pensation to the officers of the corporation, or reim-  
17 bursement for actual and necessary expenses, in  
18 amounts approved by the board of directors.

19            “(c) LOANS.—The corporation shall not make any  
20 loan to any officer, director, member, or employee of the  
21 corporation.

22            “(d) NO FEDERAL ENDORSEMENT.—The corpora-  
23 tion shall not claim congressional approval or Federal  
24 Government authority by virtue of the charter granted by  
25 this chapter for any of its activities.

1     **“§ 150410. Duty to maintain tax-exempt status**

2         “The corporation shall maintain its status as an or-  
3 ganization exempt from taxation as provided in the Inter-  
4 nal Revenue Code of 1986.

5     **“§ 150411. Records and inspection**

6         “(a) RECORDS.—The corporation shall keep—

7             “(1) correct and complete books and records of  
8 accounts;

9             “(2) minutes of any proceeding of the corpora-  
10 tion involving any of its members, the board of di-  
11 rectors, or any committee having authority under  
12 the board of directors; and

13             “(3) at its principal office, a record of the  
14 names and addresses of all members having the  
15 right to vote.

16         “(b) INSPECTION.—

17             “(1) All books and records of the corporation  
18 may be inspected by any member having the right  
19 to vote, or by any agent or attorney of such member,  
20 for any proper purpose, at any reasonable time.

21             “(2) Nothing in this section shall be construed  
22 to contravene the laws of the jurisdiction under  
23 which the corporation is incorporated or the laws of  
24 those jurisdictions within which the corporation car-  
25 ries on its activities in furtherance of its purposes  
26 within the United States and its territories.

1   **“§ 150412. Service of process**

2       “With respect to service of process, the corporation  
3   shall comply with the laws of the jurisdiction under which  
4   the corporation is incorporated and those jurisdictions  
5   within which the corporation carries on its activities in  
6   furtherance of its purposes within the United States and  
7   its territories.

8   **“§ 150413. Liability for acts of officers and agents**

9       “The corporation shall be liable for the acts of the  
10   officers and agents of the corporation when such individ-  
11   uals act within the scope of their authority.

12   **“§ 150414. Failure to comply with requirements**

13       “If the corporation fails to comply with any of the  
14   restrictions or provisions of this chapter, including the re-  
15   quirement under section 150410 of this title to maintain  
16   its status as an organization exempt from taxation, the  
17   charter granted by this chapter shall expire.

18   **“§ 150415. Annual report**

19       “(a) IN GENERAL.—The corporation shall report an-  
20   nually to Congress concerning the activities of the corpora-  
21   tion during the preceding fiscal year.

22       “(b) SUBMITTAL DATE.—Each annual report under  
23   this section shall be submitted at the same time as the  
24   report of the audit of the corporation required by section  
25   10101(b) of this title.”.

1       (b) CLERICAL AMENDMENT.—The table of chapters  
2 at the beginning of subtitle II of title 36, United States  
3 Code, is amended by inserting after the item relating to  
4 chapter 1503 the following new item:

“1504. National American Indian Veterans, Incorporated .....150401”.
