A BILL

To amend the William Wilberforce Trafficking Victims Protection Reauthorization Act of 2008 to require consultation with State and local elected officials and a public hearing before awarding grants or contracts for housing facilities for unaccompanied alien children.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Our Communities, Our
5 Choices Act of 2014”.

1 **SEC. 2. REQUIRING CONSULTATION WITH STATE AND**
2 **LOCAL ELECTED OFFICIALS AND A PUBLIC**
3 **HEARING BEFORE AWARDING GRANTS OR**
4 **CONTRACTS FOR HOUSING FACILITIES FOR**
5 **UNACCOMPANIED ALIEN CHILDREN.**

6 Section 235(i) of the William Wilberforce Trafficking
7 Victims Protection Reauthorization Act of 2008 (8 U.S.C.
8 1232(i)) is amended by adding at the end the following:
9 “Before awarding any grant or contract under this sub-
10 section that provide for housing of unaccompanied alien
11 children in a facility that is not on property of the Federal
12 Government, the Secretary shall—

13 “(1) consult with State and local elected offi-
14 cials regarding the location of the facility as well as
15 the duration of the award and the safety, security,
16 and funding of the facility; and

17 “(2) conduct a public hearing, no earlier than
18 90 days after the announcement of a potential loca-
19 tion for such facility, for which—

20 “(A) advance public notice has been pro-
21 vided, in mediums available for general circula-
22 tion in the proposed jurisdiction, at least 10
23 days before the date of the hearing; and

24 “(B) a representative of the Department of
25 Health and Human Services is in attendance in

- 1 an official capacity for the purpose of receiving
- 2 public comments.”.
