Mr. LYNCH introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To direct the Architect of the Capitol to place a chair on the grounds of the United States Capitol honoring American Prisoners of War/Missing in Action.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National POW/MIA
5 Remembrance Act of 2014”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

8 (1) In recent years, commemorative chairs hon-
9 oring American Prisoners of War/Missing in Action

1 have been placed in prominent locations across the
2 United States.

3 (2) The grounds of the United States Capitol
4 are an appropriate location to place a commemora-
5 tive chair honoring American Prisoners of War/Miss-
6 ing in Action.

7 **SEC. 3. PLACEMENT OF A CHAIR ON GROUNDS OF UNITED**
8 **STATES CAPITOL HONORING AMERICAN**
9 **PRISONERS OF WAR/MISSING IN ACTION.**

10 (a) OBTAINING CHAIR.—The Architect of the Capitol
11 shall enter into an agreement to obtain a chair featuring
12 the logo of the National League of POW/MIA Families
13 under such terms and conditions as the Architect con-
14 sidered appropriate and consistent with applicable law.

15 (b) PLACEMENT.—Not later than 2 years after the
16 date of enactment of this Act, the Architect shall place
17 the chair obtained under subsection (a) on the grounds
18 of the United States Capitol in a suitable permanent loca-
19 tion.

20 **SEC. 4. FUNDING.**

21 (a) DONATIONS.—The Architect of the Capitol
22 may—

23 (1) enter into an agreement with any organiza-
24 tion described in section 501(c)(3) of the Internal
25 Revenue Code of 1986 that is exempt from taxation

1 under section 501(a) of that Code to solicit private
2 donations to carry out the purposes of this Act; and

3 (2) accept donations of funds, property, and
4 services to carry out the purposes of this Act.

5 (b) COSTS.—All costs incurred in carrying out the
6 purposes of this Act shall be paid for with private dona-
7 tions received under subsection (a).
